With due regards, I have the honour to state that, today i.e. 7/2/2025 at around 10:30 am, a special team of Kangpokpi District Police led by Shri Rocky Pou, MPS ASP(L/O-KPI) comprising of team led by Inspt. Paokhomang Hangshing OC/Leimakhong –PS along with team of G-SPM-PS led by SI Mangpithang Kilong, team led by SI Khailet of RL/DHQ –KPI and ASI Lienjakai Haokip of KPI-PS along with his team under the over all supervision of SP-KPI conducted raid at Langka Hill Ranges for tracking down the illegal poppy cultivators in the said area. On conducting the raid at one of the Poppy fields at Langka area, 2(two) suspected Poppy Cultivators were found and detained for verification. They were later identified as 1) Maniraj Khadang (35) S/O (L) Lak Bahadur of Bajagara Villages, 25 Miles, PO-T. Waichong, Kangpokpi District. 2) Yam Bahadur Poudel (49) S/O (L) Nar Bahadur Poudel of Bajagara Villages, 25 Miles, PO-T. Waichong, Kangpokpi District. On preliminary interrogation, the two individuals were acting in a suspicious manner and on cross questioning them, they could not stand any longer and later on they confess that they had cultivated Poppy in the said area. On further search of the said area, 21 (twenty One) small cans (khaini kokta) were found wrapped in a plastic polythene and kept inside in one of the hut at the said field.
