On 27th February, 2025, I came across one video uploaded in the Facebook Account operate under the name and style 'Sanatomba Thongbam' available under the link <https://www.facebook.com/reel/1192126052336907>. In the video it is seen that two men are kissing which is very inappropriate for our society. And the same needs to be checked as the same has offended morally. On the other hand, abuse of the people's representative to such an extent is meant to provoke violence by demeaning the leader who has thousands and lakhs of followers.

Under the Information Technology Act, 2000, publishing or transmitting obscene material in electronic form is a punishable offence. The act depicted in the video is not acceptable and practice in our society. And the same may be termed as obscene, morally offended, violation of privacy, defamation, criminal conspiracy etc. accordingly. Supreme Court in its recent judgement also directed to check the contents of Youtube etc. so as to control such obscene in public/ social media platforms.

In view of the above, proper investigation may be taken up against the accused person and the relevant Facebook Account may be freeze so as not to spread such videos in the social media platforms by invoking Sections 296, 295, 356, 61(1), 61(2) BNS and 66E, 67, 67A IT Act, 2000 and any other relevant provisions of law.
