I have the honour to report that on 13/03/2025 at @ 1:25 pm one unknown youth aged about 30 yrs came to my tailoring shop located at Khurkhul Lamkhai and he purchased sweater with a

considerable amount of Rs. 250/- only. Then he also requested to give him another Rs. 2000/- in cash as he did not bring cash and in return, he will pay the total amount of Rs. 2250/- through google pay so I gave Rs. 2000/- in cash to him. And he told me that he had paid Rs. Rs. 2250/- through google pay. Then I along with him to the house of Heikham Tombi Devi (45) yrs W/o Heikham Heramani Singh of Khurkhul Makha Leikai and there he choose one Shawl (Rani Phi) worth Rs. 7500/- and in the same manner he requested Tombi Devi to give Rs. 10000/- to him by saying that he did not had cash with him and in return he will pay the total amount of Rs. 17500/- through google pay. So, she also gave him the said amount of Rs. 10000/- to him in cash. After that, he told us that he had sent the money and took the shawl and the money from her and went away. Later we found out that the money was not credited to our bank account and further found out that he had cheated us by sending forged message of transaction to our mobile number 9862956417 and 7085726290 from the mobile number 7005379887. The unknown fraudster have cheated us by sending forged messages of money transaction.

It is therefore requested to take up necessary legal action against the unknown fraudster. Relevant screenshots are enclosed.
