Sir,

I have the honour to state that today i.e. 29/01/2025 at about 12:50 pm, a reliable information was received from our own sources about the presence of some active cadres of RPF/PLA organisation in and around Paona Bazar area with a view to commit prejudicial activities like extortion of money from the general public, shops etc., teams of CDO-IW led by Shri M. Sudhirkumar Meetei, MPS, DSP (CDO)/IW assisted by Shri P. Achouba Meetei, MPS, OC-CDO-IW and myself under the command of Shri M. Amit Singh, Addl. SP(Ops.)/IW and overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP-IW conducted cordon and search operation at Paona Bazar. During that one unknown person was seen standing near Pratap Talkies in a very suspicious manner. Due to their suspicious manner, our team tried to detain him whereas he ran away towards Ibohal Cycle side. Immediately, our team chased him and successfully detained him at Kakhulong Gate, Paona Bazar after scuffle for spot verification and checking.

During spot verification, he identified himself as Nepram Bothe Meitei (24 yrs) S/o. N. Deva Meitei of Nongada Santipur Maning Leikai, Imphal East District. On spot checking, (i) one Redmi Note 8 mobile handset along with one Airtel SIM card bearing mobile number 7629843387 (as disclosed by him) and (ii) a sum of Rs. 1000/- (Rupees one thousand only) were recovered from his possession.

During preliminary verification, he disclosed that he is an active member of RPF/PLA organisation and started working for the said organisation since September, 2023 and presently working under the command of one s/s Commander namely Yengkhom Gyandas Singh (Ph. No. 8118932029) of RPF/PLA organisation. He further disclosed that today i.e. 29/01/2025, he along with his commander Yengkhom Gyandas Singh came to Paona Bazar from Mayai Lambi side by using a Royal Enfield Motorcycle black in colour (driven by him) which was taken from one Ngamba from Kongba Uchekon area and they extorted money from the shops located in and around Paona Bazar. He also disclosed that his commander fled away while seeing the police team. As pointed out by him, the said Royal Enfield Motorcycle black in colour bearing registration number MN01D 0313 was also recovered from the spot at his instance. Hence, he was arrested at the spot at 01:20 pm and the above recovered articles were seized at 01:30 pm by observing formalities.

Immediately, by considering the escape route of the above mentioned associate of the arrestee, the said team along with the arrestee rushed to Mayai Lambi side and while our team was reaching Langthabal Lep Awang Leikai area one unknown person was seen walking on the road side and on seeing our team he started running holding a gun towards a by lane road of Langthabal Lep Awang Leikai. Immediately, our team warned him to stop running by firing some rounds in the air and our team tactically overpowered him from Langthabal Lep Awang Leikai near Yensenbam Pharmacy and recovered one .32 pistol marked with "NO 1029" and "7.65" along with one magazine loaded with 7 (seven) rounds of 7.65 mm ammunitions from his possession. On spot verification, he identified himself as Yengkhom Gyandas Singh (24 yrs) @ Dinku @ Chaningkhomba S/o. Y. Premkumar Singh of Pallel Mamang Leikai, Kakching District. On spot checking, (i) one Redmi 13C mobile handset along with one Airtel SIM card bearing mobile number 8118932029 (as disclosed him) and (ii) one black wallet containing a sum of Rs. 5210/- (Rupees five thousand two hundred and ten only) and one Aadhaar card bearing number 394547208945 were also recovered from his possession.

During preliminary verification, he disclosed that he is an active cadre of RPF/PLA organisation and joined the said organisation in the year 2016 and was allotted Army No. 2399 of 2016 and is presently working under the command of one s/s Major Sumo @ Pansareng (Ph. No. 9362083910) from Yairipok area who is working as a fighting commander of RPF/PLA organisation in Bishnupur District and under the instruction of his commander, today i.e. 29/01/2025, he and his associate namely Nepram Bothe Meitei went to Paona Bazar and extorted around Rs. 5000/- (Rupees five thousand only) from the shops located in and around Paona Bazar area. Hence, he was arrested at the spot at 02:05 pm and the above recovered articles were seized at the spot at 02:13 pm by observing formalities.

Hence, the arrested persons along with the seized articles are handed over to you for taking further necessary legal action against them.
