Today i.e. on 26/02/2025 at 9.14 am received a telephonic information stating that at 1.30 am 1 (one) Vehicle Tata Truck Bearing Reg.No. AS 01JC-9238 driven by Arjun Baniya s/o Harkabadur Baniya resident of Kanglatombi Tispari , P.O & P.S - Sekmai Imphal East, carrying cement iron, bamboo coming from Imphal towards Tingsong village met accident at 10km ahead of Tingsong village thereby fell down into a deep gorge for about 15 feet. As a result one occupant namely Mohd.Talib (24)s/o Mohd.Tami of Keibung Makha Leikai,Thoubal District, Manipur died on the spot while other 5(five) occupant labours including minor injuries on their persons.

Hence, a Suo-moto case under **FIR. NO. 02(02)2025 PRL-PS U/S 281/125(b)/324(4)/106 BNS 2023** has been registered for investigation.

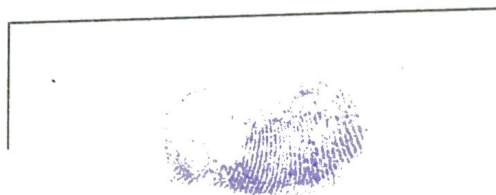
