Subject: - Report



Sir,

I have the honour to state that today i.e. 18/12/2024 at about 06:30 am, a reliable information was received from our own sources about the presence of some active cadres of KCP organisation in and around North AOC area with a view to commit prejudicial activities like extortion of money from the general public, shops etc. Acting on the information, teams of CDO-IW led by Shri P. Achouba Meetei, MPS, OC-CDO-IW and myself under the command of Shri M. Amit Singh, Addl SP(Ops) IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW conducted round patrolling at North AOC area. While our team was conducting patrolling near North AOC crossing, three unknown persons riding a Vespa scooter orange in colour were seen coming in wrong side in a very suspicious manner from Kekru Villa direction. Due to their suspicious nature, our team tried to stop them whereas they did not stop and they fled from the scene towards Khongnang Ani Karak side. Immediately, they were chased and successfully detained along with one Vespa orange in colour bearing registration number MN06SC 2466 at Thangmeiband Watham Leirak crossing and it was found that among the three detainees, there was a woman. Immediately, women police personnel were called at the spot for verification and checking.

During spot verification along with women police personnel, they identified themselves as (i) Gotimayum Shridevi Devi (27 yrs.) @ Deva @ Chinglembi D/o. (L) G. Maniroton Sharma of Thoubal Ningombam Mamang Leikai, Thoubal District, (ii) Abujam Manosh Singh (20 yrs.) @ Apaibi S/o. A. Ahanjao Singh of Salam Maning Leikai, Imphal West District and (iii) Abujam Sunder Singh (28 yrs.) @ Nanao S/o. (L) A. Iboton of Salam Maning Leikai, Imphal West District.

On spot checking by women police personnel, the following articles were recovered from the possession of Gotimayum Shridevi Devi: (i) one camouflage side bag containing two pistols i.e., (a) one pistol along with one magazine loaded with four rounds of 9 mm ammunition and (d) one .32 pistol along with one magazine loaded with six rounds of 7.65 mm ammunition, (ii) one POCO C61 mobile handset along with two Jio SIM cards bearing mobile numbers i.e. (a) 9863800974 and 8787475115 (as disclosed by her) and (iii) a sum of Rs. 1,500/- (rupees one thousand five hundred only).

On spot checking of Abujam Manosh Singh, one Redmi Note 13 mobile handset along with one Airtel SIM card bearing mobile no. 7005163041 (as disclosed by him) was recovered from his possession.

On spot checking of Abujam Sunder Singh, one POCO M6 Pro 5G mobile handset along with one Airtel SIM card bearing mobile no. 7085946330 (as disclosed by him) was recovered from his possession.

During preliminary verification, Gotimayum Shridevi Devi disclosed that she is an active cadre of KCP(MFL) organisation and joined the said organisation in the year 2018 through one Sobarani from Thoubal Athokpam and got basic military training for 45 days at Myanmar and was

allotted Army No. 334 (356 batch). Both Abujam Manosh Singh and Abujam Sunder Singh disclosed that they are active members of KCP(MFL) organisation. Further, all of them disclosed that they are presently working under the command of one s/s Commander Telheiba @ Naotiboy @ Naoba (Finance section) (Ph. No. 9862749743) from Lamlai side of KCP(MFL) organisation who is presently staying at Myanmar.

During further verification, both Shridevi and Manosh disclosed that under the instruction of their commander, on 16/12/2024, they went to Kakwa to take key of one Tata truck parked at the shop of one non-local person whereas they were unable to take the key.

On asking about the above recovered pistols, all three of them disclosed that yesterday i.e., 17/12/2024, under the instruction of their commander, they went to a camp located at Heirok Kabo Leikai by using the above mentioned Vespa orange in colour bearing registration number MN06SC 2466 (owned by Shridevi) and collected two pistols i.e., (i) one pistol along with one magazine loaded with four rounds of ammunition and (ii) one .32 pistol along with one magazine loaded with six rounds of ammunition, from one unknown person staying at the said camp and after returning from the camp, Shridevi took the above mentioned .32 pistol along with one magazine loaded with six rounds of ammunition and stayed at the residence of her friend namely RK. Tanu Devi D/o. of RK. Naobi Devi located at Khurai Salanthong and both Manosh and Sunder stayed at Kangla Guest House, North AOC and Manosh possessed the above mentioned pistol along with one magazine loaded with four rounds of ammunition. Further, they disclosed that as instructed by their commander, today i.e., 18/12/2024, they assembled at the said Kangla Guest House and the said two pistols were put in a camouflage side bag of Shridevi and all of them proceeded by using the above mentioned Vespa from the said hotel in order to fire some rounds at a shop owned by a non-local located at Kakwa by using the above mentioned pistols.

On further verification, Shridevi disclosed that she is also working for KCP(City Meitei) organisation.

Hence, (i) Gotimayum Shridevi Devi, (ii) Abujam Manosh Singh and (iii) Abujam Sunder Singh were arrested from the spot at 08:25 am, 08:30 am and 08:35 am and the above recovered articles along with one Vespa orange in colour bearing registration number MN06SC 2466 were seized from the spot at 08:38 am, 08:41 am and 08:43 respectively by observing formalities.

Hence, the arrested persons along with the seized articles are handed over to you for taking further necessary legal action against them.
