Today i.e., 18th Dec., 2024 at @ 09.00 AM, I have come across a viral post in social media Facebook page group namely "MANIPUR NEWS GROUP 2024" in which one group member under the name "Punshi Minaigi" uploaded a derogatory post "Manipur Kanse Hairadi CM Biren Amadi Magi Left Hand Right Hand Leiriba Minister Loisinba Darkar lei" It can be translated in English as "If we are to save Manipur then we need to finish CM Biren and his left right Ministers". Hence, self have taken up the matter for enquiry vide GD Entry No. 06/IPS/2024 dtd. 18/12/2024.

During the enquiry, it is found that some persons definitely and deliberately posted the statement which incites the common people to destabilise and dethrone the State Government and to revolt against the present Government led by Shri N. Biren Singh, the Hon'ble Chief Minister of Manipur and his Cabinet colleagues. The statements/ message shows the nexus between this group and those who are involved in the recent vandalization of the Houses of Hon'ble Ministers and MLAs of the State. Such statements incite for mob violence so as to prolong and continue the violence and to destroy the public peace and tranquility and disturbed the social harmony.

Moreover, the statement threatens the lives of the high functionaries of the State including the Hon'ble Chief Minister of the State and this cause an alarm to these high functionaries of the State. The Statement has intentionally insulted the present Chief Minister and his Cabinet colleagues of the State with a hidden agenda to provoke those who are supporting the present government to drag them to commit any unwanted offence in order to break public peace.

In the prevailing situation of the State, such statement has serious impact in the public peace and tranquillity as it incites violence and also creates enmity between different communities.

Hence, a suo-mottu case under FIR No. 610(12)2024 IPS U/s 49/55/61(2)(a)/61(2)(b)/148/152/196(1)(a)(b)/351(1)(c)(2)/352/3(5) BNS has been registered against the unknown fake account holder "Punshi Minaigi", unknown admin of the Facebook page group namely "MANIPUR NEWS GROUP 2024" and the unknown moderator of the above Facebook page for investigation.
