12. First Information contents:

Today i.e., 13th Jan., 2025 at @ 3.30 PM, found a viral video of the interview of some victims of an alleged fraudulent company QNET uploaded in the YouTube by "R.K Production" with the description, "Meitel gi Danger Noida Sector-143" on 12th Jan., 2025 with more than 2,81,167 views. During the interview it came to light that the victims from different parts of Manipur were lured and enticed by the official members of the alleged fraudulent company QNET who are from Manipur on the pretext of giving job opportunities and business opportunities outside Manipur. The victims were allegedly deceived by the official members of QNET for their wrongful personal gain. As per the interview, the victims were called at Noida with the promises of job interview and placement. However, on arrival at Noida they were subjected to be cheated and defraud by the official members of the QNET. They were forced to invest a sum of Rs 1 Lakh to 3 Lakhs per individual to get job or to secure a business opportunity. They were even forced to recruit other young job aspirants into the alleged fraudulent scheme contributing to the apparent pyramid-like structure. If they fail to invest the said amount or fail to recruit others they were threatened with dire consequences, and they were wrongfully restrained and confined inside a room at sector-143 Noida. It is also come to light that the mastermind and active members of the alleged fraudulent company QNET are 1. Yengkhom Umendra Singh of Kakching, 2. Akoijam Oken of Mayang-Imphal, 3. Kennedy of Wangoi, 4. Heisnam Manikumar of Bishnupur, 5. Moirangthem Babloo of Kakching, 6. Moirangthem Ariya, 7. Thokchom Saratkumar of Thoubal Wangbal, 8. Ningthoujam Pushpa of Mayang Imphal, 9. Thokchom Milan of Wangbal, 10. Ningombam Dingku Singh of Thoubal Leishangthem, 11. Rakesh Khomdram of Mayang Imphal & 12. Dhananjoy of Thanga and others.

Hence, a suo-mottu case under FIR No. 13(01)2025 IPS u/s 109(1)/126(2)/127(7)/316(2)/318(4)/351(2)/61(2) BNS has been registered for investigation.
