Sir,

I have the honour to state the following few lines for your kind perusal and necessary action.

That, today i.e, 20th January, 2025 at about 9.00 am, one individual namely Thounaojam Sanatombi aged about 55 years of Sagolband Ingudam Leirak, Imphal West District, Manipur along with his associates Thounaojam Hemanta @ Bhalok (57), Khumanthem Bir Singh (55), Thounaojam Muhindro (64), Khumukcham Sunil (55), Yumnam Sobita Devi (55), Thounaojam (O) Roshni Devi (35), Thounaojam (O) Binokumari Devi, all residents of Sagolband Ingudam Leirak, Imphal West District, Manipur and 50/60 others came at our homestead land under old patta No. 85/996 corresponding to new patta No. 2866 covered by C.S. Dag No. 8056 measuring .0600 hectare situated at Sagolband Thangjam Leirak within Revenue Village No. 85 Sagolband of 1987. They asked me to vacate our homestead land as the property is belong to one Keisham Sanatomba Singh (46) S/o (L) Keisham Shantikumar Singh of Thangmeiband Lairen Hanjaba Leikai, Imphal West which a land dispute case is now pending before the Civil Judge Junior Division, Imphal West by taking law in their hands. They became more and more violent, and they started vandalizing the entire structure. Further, the irate mob assaulted me by using deadly weapons and they also assaulted my old aged mother namely Mutum (O) Irengbam Umabati Devi (65). As a result of which both myself and my mother sustained severe injuries on our persons and evacuated to JNIMS Hospital for medical treatments. Now, the above mentioned culprits physically possessed the disputed land by chasing away the true owner of the property without any order from the law court or any authority by taking law in their hand.

It is therefore requested kindly take up necessary legal action at the earliest according to the law of land.


