Sir,

With due respect, I have the honor to report that on 20/01/2025 at @ 11.30 PM my old aged mother namely Nandeibam Radhe (75 yrs) W/O (L) N. Ibungomacha of Moirangkhom Sougaijam Leirak, P.O & P.S- Imphal, Imphal West District was physically assaulted by my younger brother namely Nandeibam Surjabarna (42 yrs) @ Thenthen while she was sleeping at her bed by using a blunt object without any reason. It came to our noticed that yesterday my brother came home after consuming liquor and demanded a sum of Rs 5000/- to my mother for his alcohol consumption. It is to mention that my brother is a drunkard/alcoholic person and whenever he is in the state of intoxication he started abusing and ill treat our old aged mother. His wife along with his two son's also left home one month back due to his wild and violent behavior. As a result, my old aged mother received severe injuries on her person and she was evacuated to JNIMS hospital for medical treatment.

It, is therefore, requested your good self to kindly take up necessary legal action against my younger brother namely Nandeibam Surjabarna (42 yrs) @ Thenthen at the earliest.


