## 12. First Information contents:

Today i.e 25/01/2025 at @ 08.00 PM, I came across a viral video in social media where one individual is giving a defamatory, intimidating and threatening statement against the government. The statement of the said individual is reproduced as follows, "We have the right to criticize the MLA's and Government. Everyone should know that, social media is not created by the dirty MLA's. The weak/fragile Government does not have the right to ban the social media. Even the Prime Minister of India, Modi does not ban social media. Unnecessarily they are creating communal tension; (Laura) I will urinate on your mouth. Don't act smart and don't act like a hero. Instead of banning social media let the internally displaced persons who are in Relief Camp's settled in their respective home. We selected you as MLA's and Chief Minister by giving our right to vote. We will urinate all of you in your mouth. Biren you are nothing, we even criticize Prime Minister of India, Modi (motherchod). The viral video directly threats, humiliated and insulted the MLA's of Manipur and Hon'ble CM of Manipur. Moreover, transmitting such hate videos at this juncture of crisis in Manipur provokes the general public and is likely to disturb the maintenance of harmony, public order and public tranquillity in the state. Circulating such hate, false and alarming videos in the midst of the crisis also mislead the different communities which promotes hatred, enmity, revenge and retaliation at this juncture where the restoration of peace is being started between the different communities.

Hence, a suo-mottu case under FIR No. 32(01)2025 IPS U/s 351(2)/356(2)/196(1)(a)(b)/353(1)(b)(c)(2)/61(2) BNS has been registered for investigation.




