Sir,

With due respect, I have the honour to state the following few lines for your kind perusal and taking further necessary action.

That, on 17th April, 2024, one Senjam Sobita Devi (50) W/o S. Dijen Singh of Khuyathong Polem Leikai, Imphal West District, Manipur along with one Lourembam Kiranbala Devi of Haobam Marak Lourembam Leikai, Imphal West District, Manipur came to my residence located at Thangmeiband Lourung Pural Leikai, Imphal and mortgaged a pension book of Lourembam Kiranbala Devi of Haobam Marak Lourembam Leikai, Imphal West District, Manipur and took a total amount of Rs. 5,00,000/- (five lakhs) on different occasion with an interest rate of 3% per month and promised to return the same within 5 months. Further, on 18th May, 2024 she came to my residence and mortgaged another pension book of one Potshangbam Nomita Devi of Singjamei Oinam Thingel, Imphal and took a sum amount of Rs. 70,000/- (seventy thousand) and promised to return the same within a month. However, she fails to return my money till date and the pension books she gave was also suspected to be a fake one. I have requested her several times to return my money but instead, she threatened me with dire consequences.

It is therefore, requested kindly to take up necessary legal action against the said Senjam Sobita Devi and Lourembam Kiranbala Devi as per law.
