Sir,

I have the honour to report today i.e., 7th January, 2025 at about 08.00 AM, a team of Traffic Police, Imphal West led by myself along with 1) VDF No. V111998 Moirangthem Rozer, 2) V111337 Shougrakpam Michael Singh, 3) V112641 Md. Iqbal, 4) V111530 Thoudam Devenkumar Singh and 5) Constable No. 0915763 K. Hemchand under the supervision of SP-Traffic, Imphal West conducted a special drive in front of Nupi Lal Complex, Imphal West. During the traffic special drive, one Jupiter scooter bearing Regd. No. MN01B-4572, Silver in colour having Chassis No. MD626EG42K1C17569 & Engine No. EG4CK1X11148, was stopped for checking and verification. On spot checking, the rider of the Jupiter scooter is identified as one Md. Eliyas Khan (23) S/o Makakmayum Hellaluddin of Lilong Chingjao and he produce one photo copy of the RC book of the vehicle standing in the name of one Md. Hellaluddin S/o Md. Rahajuddin of Lilong Nungei Ching suspected to be a forged one. On further checking of the engine number and chassis number of the vehicle due to his suspicious nature it was found that the vehicle is standing in the name of one Langpoklakpam Chalamba Meitei S/o L. Rajen of Sangakpam Poumai Colony, Imphal East and the original registration number of the vehicle is MN01AH-6011, Black in colour. It was also found that the vehicle was stolen in the year 2022 from Chingmeirong near MBC Church. So, the vehicle was seized in presence of the witnesses by observing formalities at 11.45 AM and the rider of the vehicle was also arrested at 11.50 AM.

Hence, the seized vehicle along with the arrested person is handed over to you for further necessary legal proceedings.
