Sir,

I am a law-abiding citizen of India, and a member of Bhartiya Janata Party (BJP). I am presently holding the post of Spokesperson, BJP, Manipur Pradesh. The present complaint is being filed against the unknown accused person (female) who appeared in the above mentioned facebook linked video uploaded in the Facebook Account 'Wangthouba Ningombam' ([Wangthouba Ningombam Reels | Facebook](#)) for taking up necessary legal action and to punish her in accordance with law for her unlawful activities.

Today at Imphal, the complainant came to know that a video was uploaded by the accused person in 'facebook' in which she had defamed the Spokesperson of BJP as well as the BJP thereby spreading false, concocted stories, defaming and misleading statements to the people.

The accused person in her short reel available in the links(i) <https://www.facebook.com/reel/3932169513695953> and (ii) <https://www.facebook.com/share/r/19nFhp13Wr/?mibextid=UaiRPS> intentionally made fun and defamed the Spokesperson of BJP by using and spreading the defaming words commented in social media including mocker words in Manipuri language. The unlawful activities of the accused person are not only defaming the Spokesperson but also defaming the Bhartiya Janata Party (BJP).

The accused person has harmed the reputation of the Spokesperson of BJP and the same does not fall within the ambit of reasonable restriction as any comment or remark which hampers the reputation of another person would invite liability under the law of defamation. The present defamatory statement is made

in a verbal form (spoken) and the same was made viral via social media platforms.

The accused person has committed the offence of defaming the Spokesperson of BJP as well as the BJP as a whole thereby misusing the social media platform for spreading of false and fake information. The Facebook post and those who have commented in his Facebook post not only insult and defame the Spokesperson and BJP party but also causes fear and alarm to the general public, or to induce any person to commit any offence against the public tranquillity and incites any class of community promoting enmity, hatred or ill-will between classes on the ground of religion caste or community at this juncture of crisis in Manipur. Strict legal action is to be taken against the accused person so as to stop her from further commission of illegalities. It is further to mention that the act of the accused person is punishable under Sections 61(2), 237, 356, 356(2)/196(1)(a)(b)/353(1)(b)(c)(2) of BNS etc. and any other relevant Sections/ Provisions under any other relevant laws/ enactment.

It is, therefore, requested you to make a thorough investigation into the matter so as to punish the accused persons in accordance with the relevant provisions of law.
