Today i.e. 8<sup>th</sup> Jan., 2025 at 02.20 PM received information that on the same day at @ 02.10 PM a fire broke out at the shed of one abandoned house belonging to the Kuki community near Kuki Inn, Old Lambulane, Imphal.
