

I, the undersigned would like to report that, vide SP/CCP Order No. mentioned above, combine team comprising of District Police/ Churachandpur, Mahar Regiment, NAB/ Churachandpur, CCP/ Forest Division and CCP-PS team in the prsence of Executive Magistrate launched destruction of illegal poppy cultivation in Changpikot Hill Range, Near Kotzim Village, Churachandpur from 10:30 am to 2:00 pm. Total area of illegal poppy cultivation destructed was estimated to be 05 acres approximately. During the operation, no arrest was made and the cultivators are not known. However, 10 pieces of poppy plants with pods have been seized in the presence of witnesses at about 1:25 pm.
