O LODGE AN FIR AGAINST MR SEIMINLEN DOUNGEL.

Sir,



- 1. 36 Assam Rifles had been tracking the movement & activities of the apprehended individual namely, Mr Seiminlen Doungel (Age 35 years, S/o Holthang Doungel, r/o Vill Tuibong, District-Churachandpur) belonging to the UKNA groups. Various inputs through own human & technical sources confirmed the movement of the ibid implicated individual in various unlawful activities like extortion, kidnapping, weapon smuggling & drug trafficking from across the IMB on behalf of UKNA.
- 2. On 16 Feb 25 at approx 2230 Hr, an input was received from 11 WEU that one of Seiminlen's mobile number has been switched ON in the gen area of Kaprang, Churachandpur.
- 3. A team of 36 Assam Rifles was immediately activated from HQ Veng, CCPur led by a Nb Sub Twarsu Ram Dogra alongwith a str of 24 individuals. The team laid a cordon to apprehend the suspected individual, who was being continuously tracked by own sources.
- 4. When one team moved in to apprehend the person on a pre-designated signal, the suspected person attempted to flee from the rear of the house using cover of darkness. Seeing the fleeing suspect, own team reached swiftly & communicated the location of the suspect to the cordon team, which successfully apprehended the supect along with the weapon.
- 5. The suspect tried to flee by breaking the cordon physically but was chased off and overpowered & apprehended at 2345 hrs on 16 Feb 2025. Thereafter the team of 36 Assam Rifles took the suspected person to Bn HQ Veng at 0030 hrs on 17 Feb 2025 & investigated the suspected person with respect to his identity, intent and activities. The suspected person was kept in custody of 36 Assam Rifles at Quarter Guard during the investigations.
- Due to threat from the UKNA gp to the suspect as well as the Police Station it was requested by the Police authorities to produce the suspect during day time on 18 Feb 25 so that the suspect can be taken directly to Judicial Magistrate under the security of Assam Rifles. The suspected person was handed over to the Police team on 18 Feb 2025 at 08:10 AM at CCPur PS with a 'No Claim', Medical & NOC certificate duly signed by suspect, police & 36 Assam rifles. The suspect is to be produced before the Hon'ble Magistrate, Churachandpur (Manipur) for due legal action.
- 7. The investigation revealed the following:-
- (a) The suspect was involved in illegal & anti-national activities to include extortion, kidnapping, weapon smuggling & drug trafficking from across the IMB on behalf of UKNA which are a threat to national security.
- (b) On investigation about weapons, it is clear that the presence & dealing of the suspect in such weapons clearly indicates threat to national security & likely to cause unrest in the already fragile ethnic tensions in the state.
- (c) On investigation about mobile phones carried by the suspect, it is revealed that he is a part of an organized crime syndicate operational in several areas of Churachandpur district (Manipur). Furthermore, such syndicates are felicitating high extortion, thus troubling the general populace. Several contacts, photos, Whatsapp chats, conversation messages were seen in the mobile phone of the suspect.
- 8. It is clear from the above investigation, that the suspect is heavily involved in several anti-national activities, thus challenging the writ of the state, rule of law & national security & integrity & recommended to be charged under appropriate sections of IPC.


