Sub: To lodge an FIR against Mr Mangsei Guite

Sir,

1. 36 Assam Rifles had been tracking the movement and activities of the apprehended individual namely Mr Mangsei Guite @ Mas Guite (age 45 yrs) s/o Late Seilam Guite, r/o House No. 410 Belam Veng, District- Churachandpur belonging to the IMB VV groups, a non SoO gp now renamed as Chin Kuki Mizo Army (CKMA). Various inputs through own human and technical sources confirmed the involvement of the ibid implicated individual in various unlawful activities like weapon smuggling and drug trafficking from across the IMB on behalf of IMB VV.

2. The individual was under surveillance since Dec 2024. His new mobile number was confirmed from phone of Mr Seiminlen Dounel, Finance Secretary of UKNA after his arrest on 16 Feb 25. A conversation with Mr Seiminlen Dounel, Finance Secretary of UKNA implicates Mr Mangsei in weapon smuggling across IMB and selling it to non SoO gps has been attached as Appendix A.

3. The new number of Mr Mangsei recovered from Mr Seiminlen's phone was put under surveillance. On 20 Feb 25 at around 0445 hrs. 11 WEU located the said number at Belam Veng and it was further confirmed and corroborated by own sources. A team of 36 Assam Rifles was immediately activated from HQ Veng, CCPur led by a Nb Sub DK Rai alongwith a str of 20 individuals. The team laid a cordon to apprehend the suspected individual, who was being continuously tracked by sources.

4. When own team moved in to apprehend the person on a pre designated signal, the suspected person attempted to flee. Seeing the fleeing suspect, own team reached swiftly and communicated the location of the suspect to the cordon team, which successfully apprehended the suspect at 0915 hrs on 20 Feb 25. A mobile phone was confiscated from individual's possession. Thereafter the team of 36 Assam Rifles took the suspected person to Bn HQ Veng and investigated the suspected person with respect to his identity, intent and activities. The suspected person was kept in



custody of 36 Assam Rifles at Quarter Guard during the investigations.

5. The suspected person was handed over to the police team on 20 Feb 25 at 2130 hrs at CCPur-PS with a No Claim, Medical and NOC Certificate duly signed by suspect, police and 36 Assam Rifles. The suspect is to be produced before the Hon'ble Magistrate, Churachandpur (Manipur) for due legal action.

6. The investigation revealed the following:

(a). The suspect is General Secretary of IMBB VV, a non SoO group who are involved in drug trafficking, gold and weapon smuggling across IMB. Photos attached as Appendix B. He was involved in illegal and anti national activities on behalf of IMB VV which are a threat to national security. A letter initiated under name Mas Guite, general secretary is attached as Appendix C.

(b). On investigation about weapons, it is clear that the individual has been selling weapons to non SoO groups. The presence and dealing of the suspect in such weapons clearly indicates threat to national security and likely to cause unrest in the already fragile ethnic tensions in the state. A screenshot of conversation is attached as Appendix D and the same is also confirmed from Appendix A.

(c). On investigation about mobile phones carried by the suspect, it is revealed that he is part of an organized crime syndicate operational in several areas of Churachandpur District (Manipur). Further more, such syndicates are facilitating move of drugs and weapons as well as troubling the general populace. Several contacts, photos, whatsapp chats, conversation messages were seen in the mobile phone of the suspect. Screenshots of various whatsapp group is attached as Appendix E.

(d). On checking of conversation, it came to light that individual is operating with foreign national and have messages implicating him in across border insurgent activity. Screenshot of conversation is attached as Appendix F.

(e). On investigation it was learnt that Mr Mangsei Guite has supplied arms, ammunition and explosive which were used in Jiribam in Apr and Nov 2024.

(f). Further, it was learnt that Mr Mangsei Guite through his group is involved in illegal poppy cultivation of 15 acres in and around Mongjang Village. Screenshot of list of persons involved in poppy cultivation is attached as Appendix G.

7. It is clear from the above investigation, that the suspect is heavily involved in several anti national activities, thus challenging the writ of the state, rule of law and national security and integrity and recommended to be charged under appropriate sections of IPC.

Sir,

1. 36 Assam Rifles had been tracking the movement & activities of the apprehended individual namely Mr Mangsei Guite @ Mas Guite (Age 45 yrs years, S/o Late Seilam Guite, r/o House No 410 Belam Veng, District- Churachandpur) belonging to the IMB VV groups, a non SoO gp now renamed as Chin Kuki Mizo Army (CKMA). Various inputs through own human & technical sources confirmed the involvement of the ibid implicated individual in various unlawful activities like weapon smuggling & drug trafficking from across the IMB on behalf of IMB VV.

2. The individual was under surveillance since Dec 2024. His new mobile number was confirmed from phone of Mr Seiminlen Doungel, Finance Secratory of UKNA after his arrest on 16 Feb 25. A conversation with Mr Seiminlen Doungel, Finance Secratory of UKNA implicates Mr Mangsei in weapon smuggling across IMB and selling it to non SoO gps has been attached as **Appendix A**.

3. The new number of Mr Mangsei recovered from Mr Seiminlen's phone was put under surveillance. On 20 Feb 25 at around 0445 hrs, 11WEU located the said number at Belam Veng and it was further confirmed and corroborated by own sources. A team of 36 Assam Rifles was immediately activated from HQ Veng, CCpur led by a Nb Sub D K Rai alongwith a str of 20 individuals. The team laid a cordon to apprehend the suspected individual, who was being continuously tracked by sources.

4. When own team moved in to apprehend the person on a pre-designated signal, the suspected person attempted to flee. Seeing the fleeing suspect, own team reacted swiftly & communicated the location of the suspect to the cordon team, which successfully apprehended the suspect at 0915 hrs on 20 Feb 25. A mobile phone was confiscated from individual's possession. Thereafter the team of 36 Assam Rifles took the suspected person to Bn HQ Veng & investigated the suspected person with respect to his identity, intent and activities. The suspected person was kept in custody of 36 Assam Rifles at Quarter Guard during the investigations.

6. The suspected person was handed over to the police team on 20 Feb 25 at 2130 hrs at CCPur PS with a 'No Claim', Medical & NOC certificate duly signed by suspect, police & 36 Assam Rifles. The suspect is to be produced before the Hon'ble Magistrate, Churachandpur (Manipur) for due legal action.

7. The investigation revealed the following:-

(a) The suspect is General Secretary of IMBB VV, a non SoO group who are involved in drug trafficking, gold and weapon smuggling across IMB. Photos attached as **Appendix B**. He was involved in illegal & anti-national activities on behalf of IMB VV which are a threat to national security. A letter initiated under name Mas Guite, general secretary is attached as **Appendix C**.

(b) On investigation about weapons, it is clear that the individual has been selling weapons to non SoO groups. The presence & dealing of the suspect in such weapons clearly indicates threat to national security & likely to cause unrest in the already fragile ethnic tensions in the state. A screenshot of conversation is attached as **Appendix D** and the same is also confirmed from **Appendix A**.

(c) On investigation about mobile phones carried by the suspect, it is revealed that he is part of an organized crime syndicate operational in several areas of Churachandpur district (Manipur). Furthermore, such syndicates are facilitating move of drugs and weapons as well as are troubling the general populace. Several contacts, photos, WhatsApp chats, conversation messages were seen in the mobile phone of the suspect. Screenshots of various Whatsapp group is attached as **Appendix E**.

(d) On checking of conversation, it came to light that individual is operating with foreign national and have messages implicating him in across border insurgent activity. Screenshots of conversation is attached as **Appendix F**.

(e) On investigation, it was learnt that Mr Mangsei Guite has supplied arms, ammunition and explosives which were used in Jiribam in Apr and Nov 2024.

(f) Further, it was learnt that Mr Mangsei Guite through his group is involved in illegal poppy cultivation of 15 acres in and around Mongjang village. Screenshot of list of persons involved in poppy cultivation is attached as **Appendix G**

9. It is clear from the above investigation, that the suspect is heavily involved in several anti-national activities, thus challenging the writ of the state, rule of law & national security & integrity & recommended to be charged under appropriate sections of IPC.

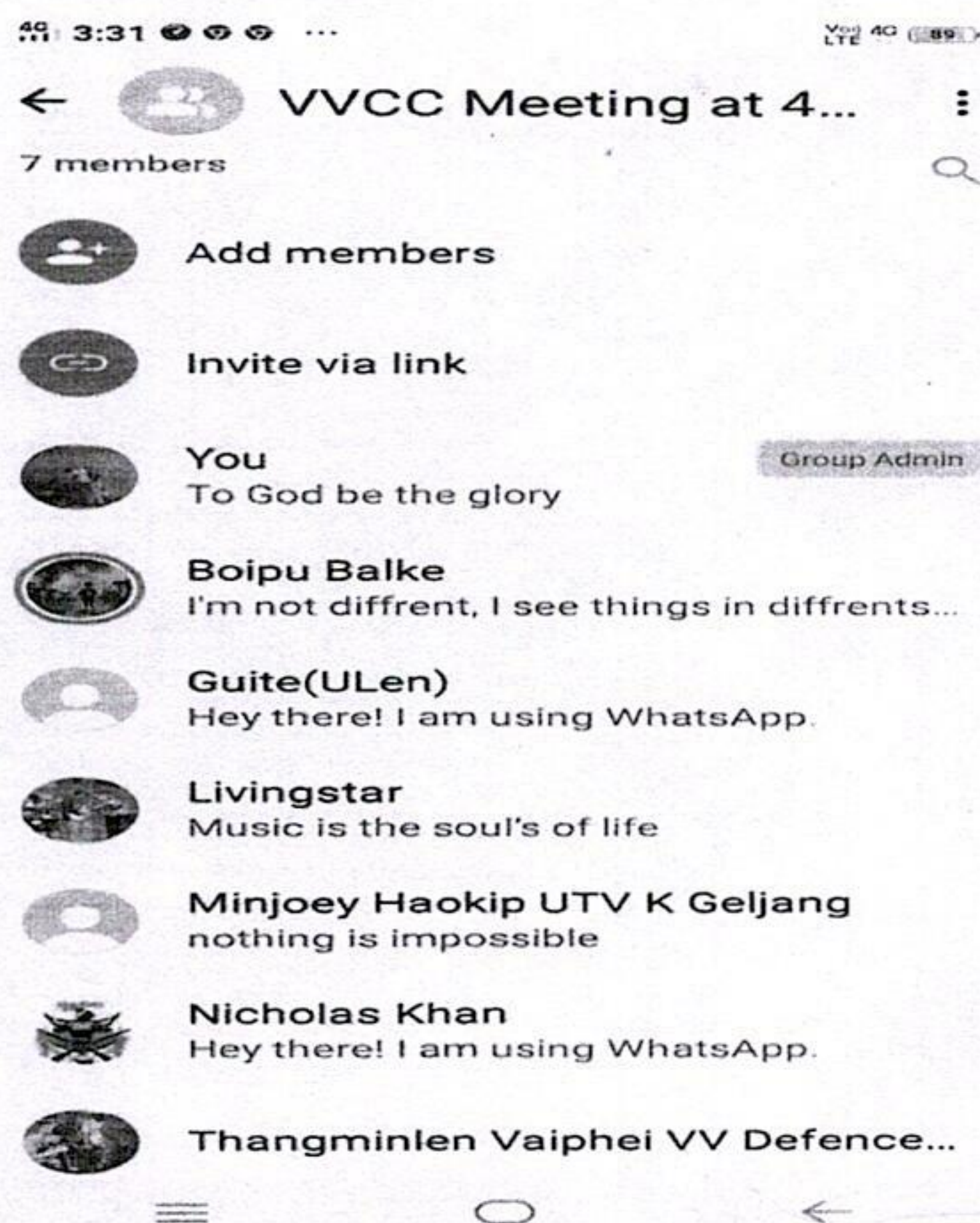
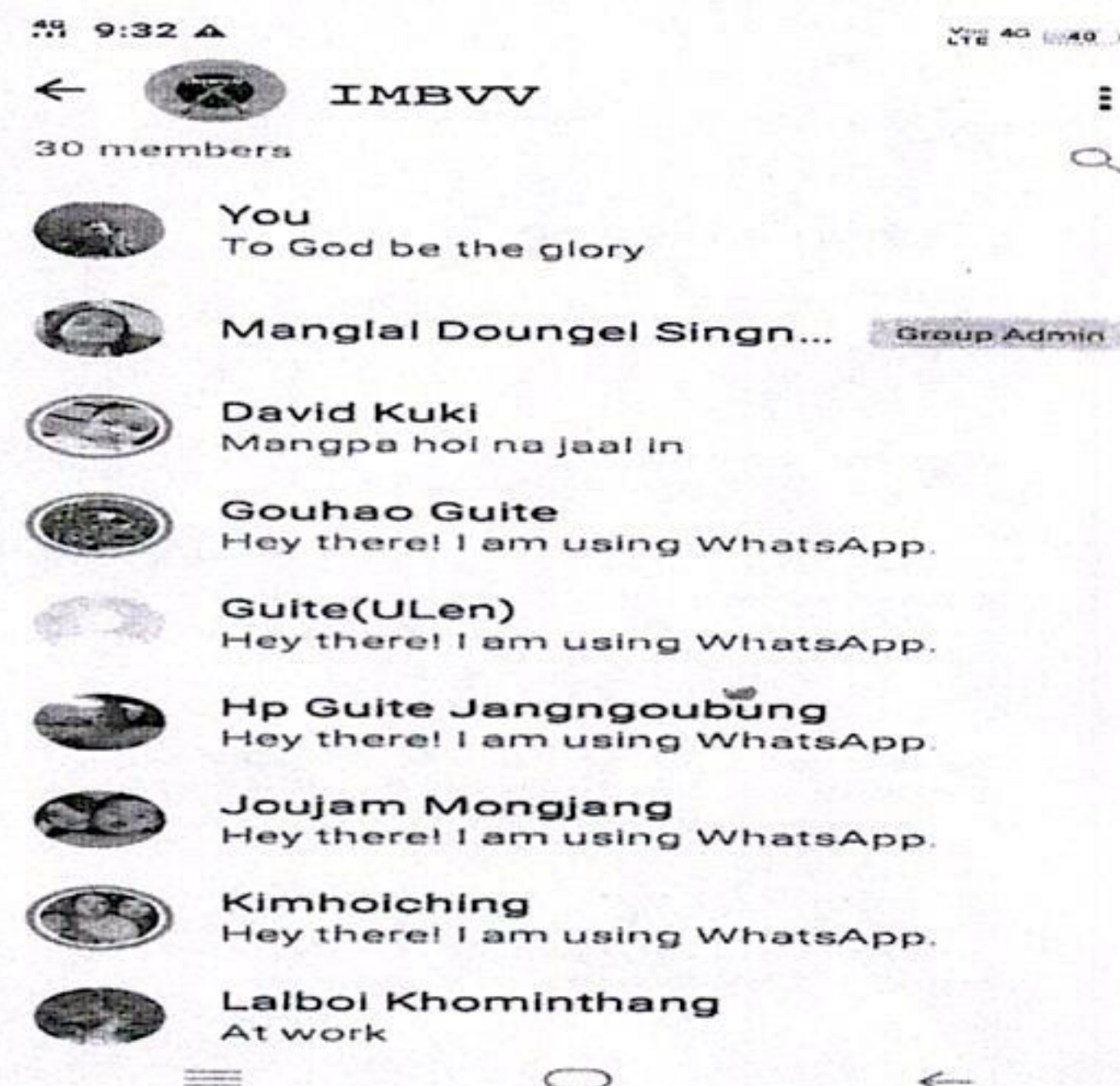
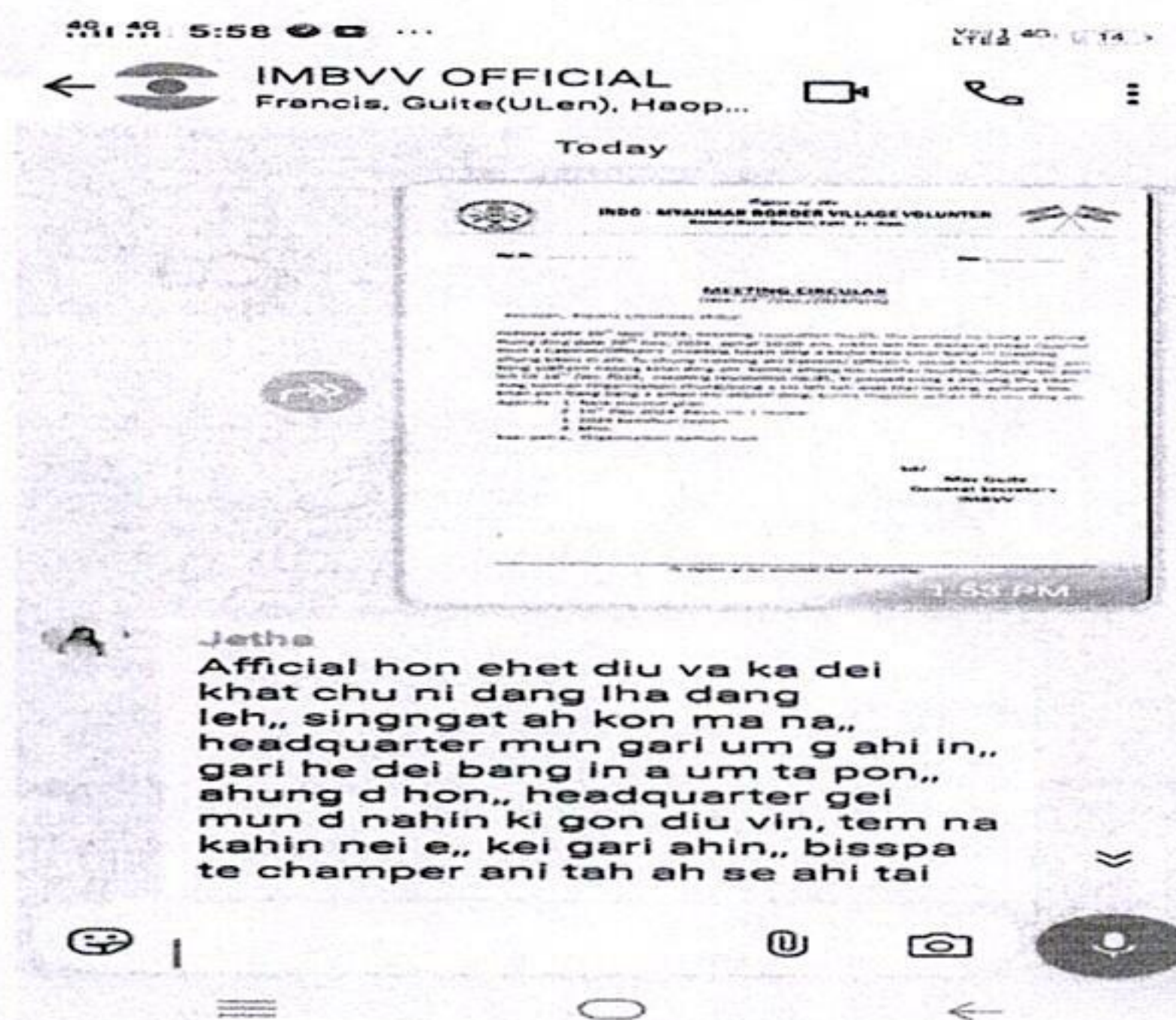


SCREENSHOT OF WEAPON DEAL BETWEEN PAOMIN GUTE AND MANGSEI GUTE

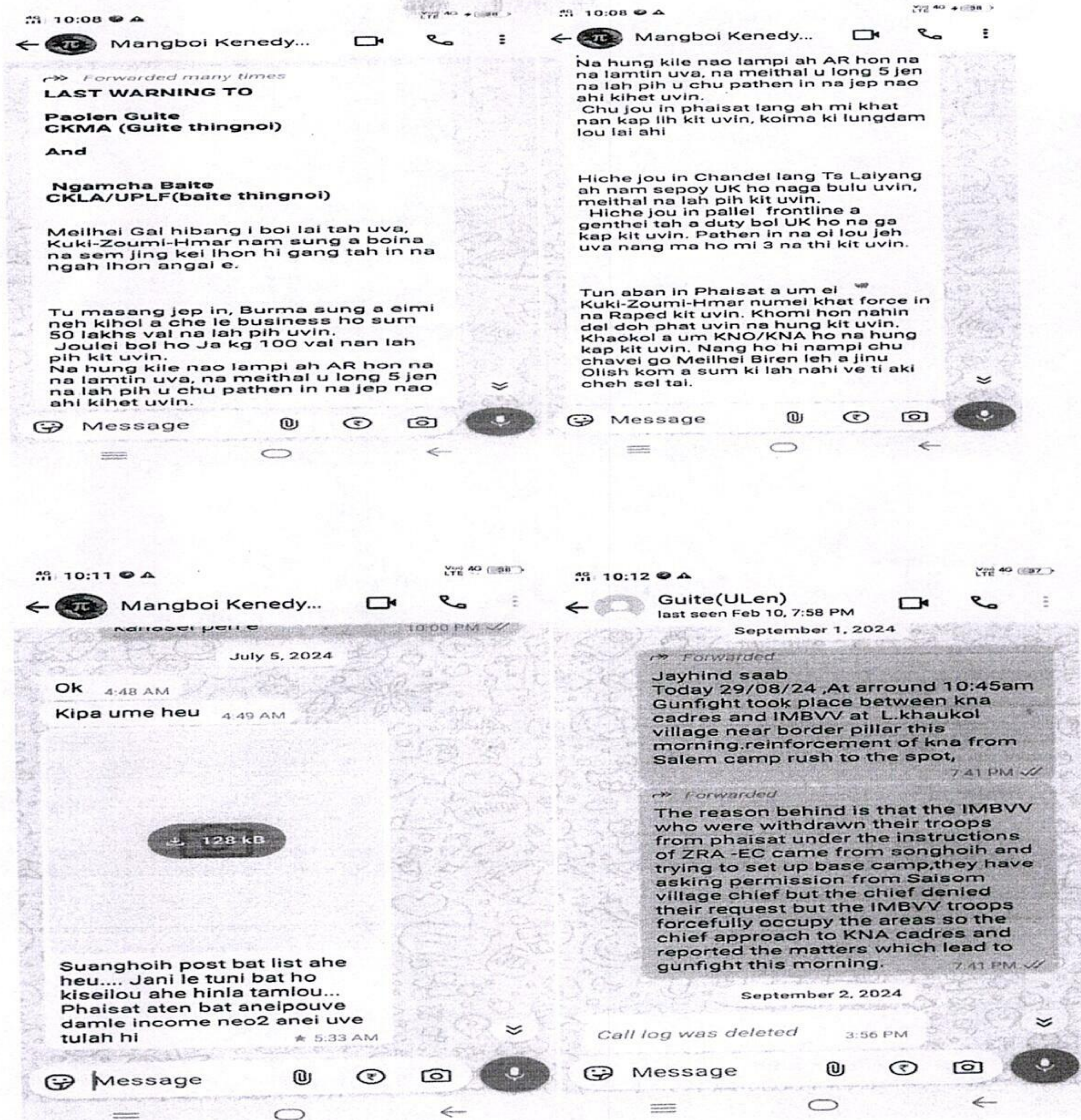
SCREENSHOT OF WHATSAPP GROUPS ASSOCIATED WITH NON SoO GROUPS

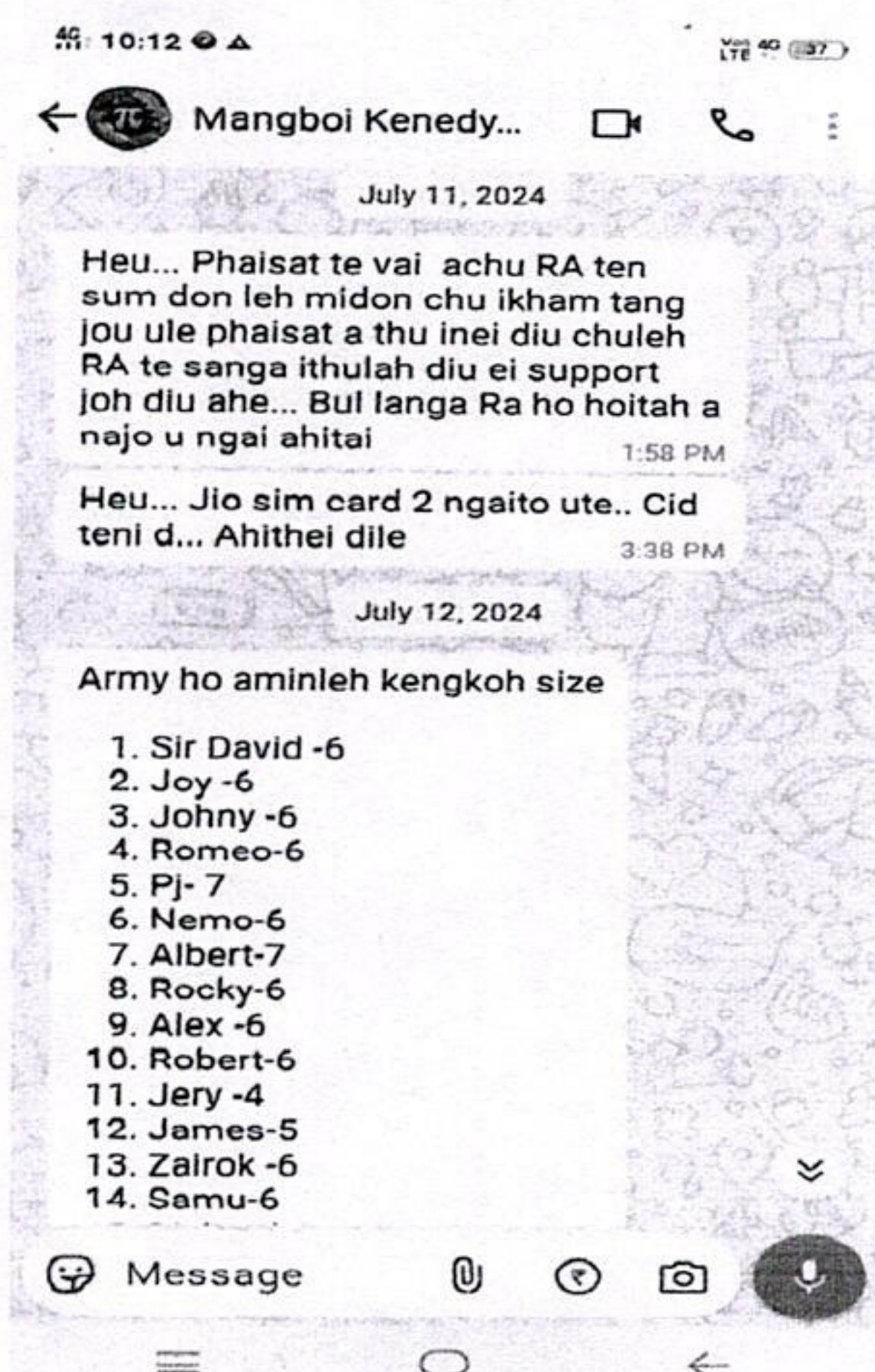
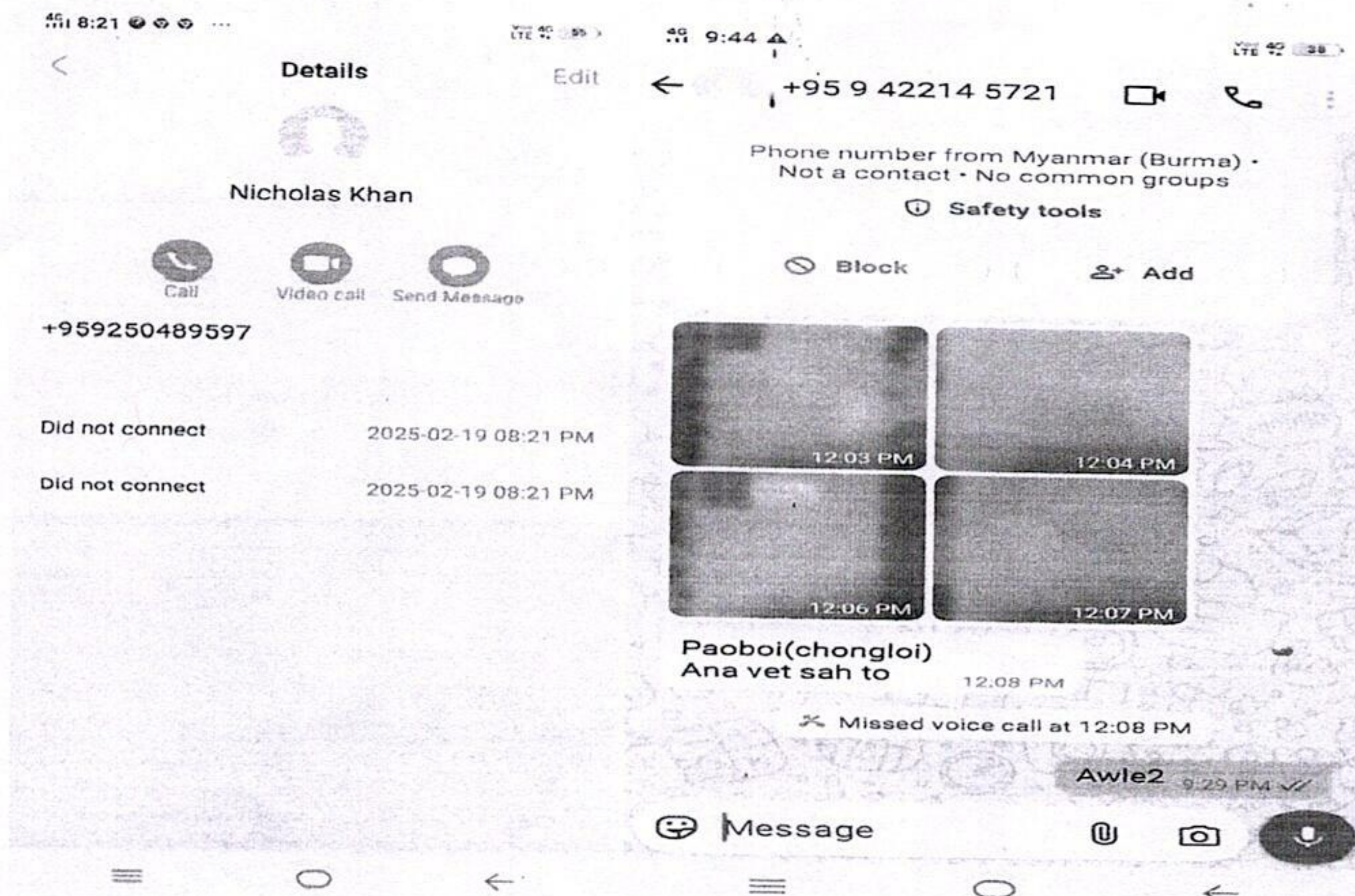
