I, Jagnarayan Prasad aged about 70 years S/O Late Ramdhari Prasad, Proprietor, Jagnarayan Store, Kalibari Road, Thangal Bazar would like to state a few words for your necessary action that today i.e 09/01/2025 our vehicle TATA DI bearing Regd. No. MN01X 6890 loaded with edible oil, tin fish and water bottles amounting an amount of Rs. 2,00,000/- (two lakhs) plying from my godown located at Ahallup, Imphal East District, Manipur and transported towards my store, i.e Jagnarayan Store, Kalibari Road, Thangal Bazar, Imphal but he could not reach the store. The said vehicle was drove by our driver namely Akoijam Ratan singh 46 yearsrs S/O AK. Gouradas Singh of Naharup Awang Leikai after loading the abovementioned items from the godown at around 10:10 a.m. The driver along with the loaded vehicle seems to be kidnapped by an unknown miscreants on the way from Ahallup to my store, Kalibari Road, Thangal Bazar, Imphal as many unknown miscreants threatened me earlier regarding monetary demand. Further I have lost contact with the driver of the vehicle.

So, i requested your humble and good office to take necessary action against them as per law and to find out the missing driver and loaded vehicle at the earliest.


