That, I was contacted by one unknown person using mobile no: 8431742043/ 7085805494 claiming himself to be Mr James a Subedar from the Assam Rifles that he was interested in the post and would like to meet in person to finalise the deal. That, on 22/02/2025 at around 10:00 AM we met with him in person in front of the gate of 27 Sector Assam Rifles, Tuibong who was also coming out of the gate at that exact time. He checked the vehicle and test drive was also conducted by him, He gave me a Multi City Cheque of SBI/ Churachandpur Branch, Account Number: 42371324180 amounting to Rs 3,85,000/- and the deal was finalised and he left with the vehicle. Without suspecting any foul play we handed over the Mahindra Bolero and he handed over the Multi City Cheque of Rs 3,85,000/- in the name of Mr Paumuanlun. As the cheque was in the name of Mr Paumuanlun we enquired about it and he stated that he was using his friend's cheque as he have no money and we parted ways. As bank was closed on that particular day, we went to the bank today ie 24/02/2025 to withdraw the amount, but was rejected as the was no money in the account and that there was over writing in the cheque. Suspecting something fishy, we checked for the account number with the bank staffs and it was found that it was in the name of Mr Khamzamang of M Saljang Village, Churachandpur (7085743232). On trying to contact his number all his phone number was switched off and it was only at that moment that we found out that we have been cheated by him.

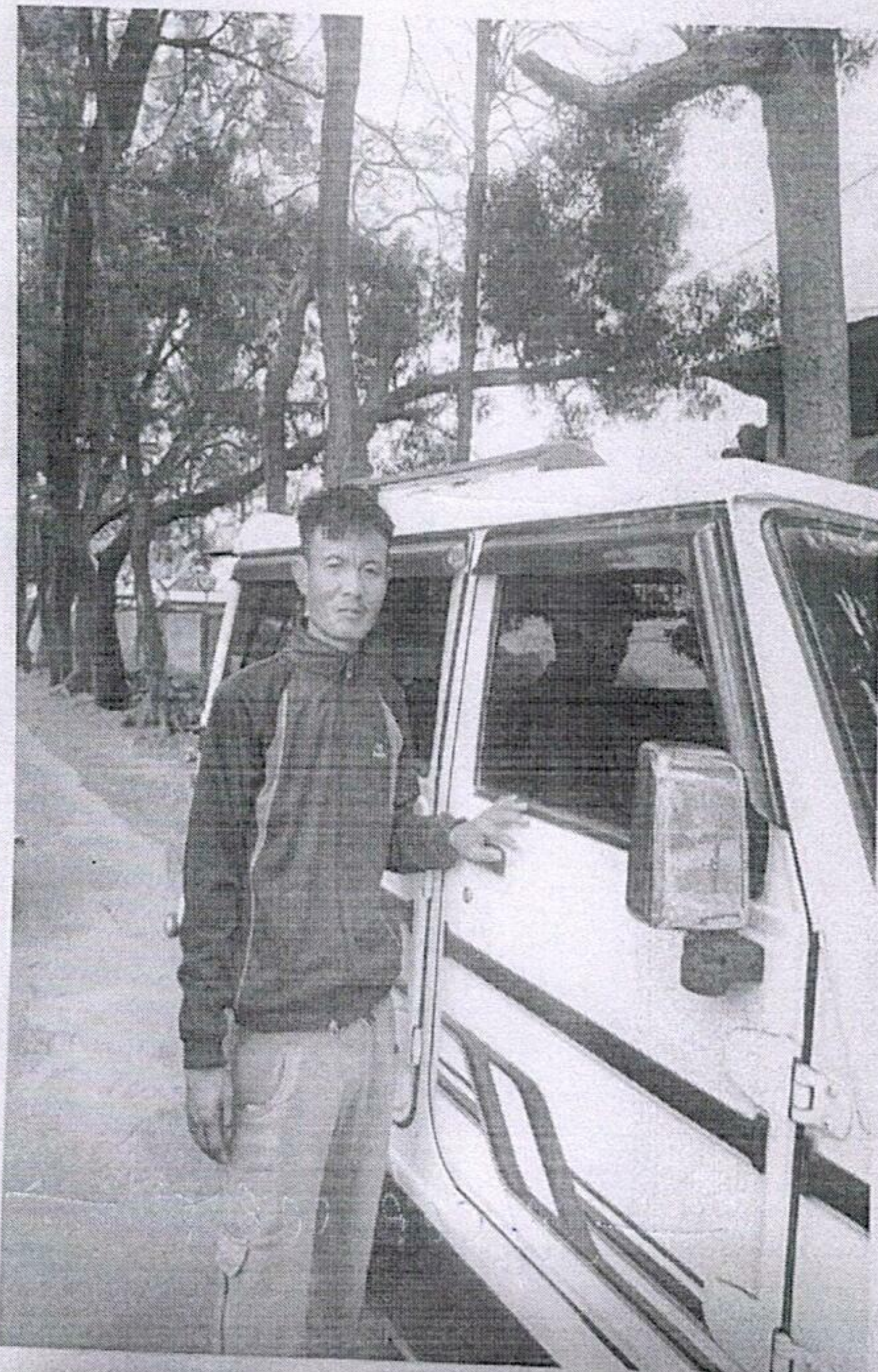
