Sir,

1. 36 Assam Rifles had been tracking the movement & activities of the apprehended individuals namely :-

- (a) Holkholal Khongsai @Matthew s/o Gunkhomang Khongsai r/o Gamngai , chandel. Upon Re-Medical examination individual complaint of dizziness and got admitted in District Hospital Churachandpur (OPD sheet att)
- (b) Ngamkhomang Haokip @ Jack s/o Jamkhong Haokip r/o T. Munnumjang, churachandpur
- (c) Ngamgoulun Haokip @ Hitler s/o Dongthang Haokip r/o Gamnom, churachandpur
- (d) Janggoulun Haokip @ Marco s/o Khupngam Haokip r/o Pangmol, KPI

2. There were inputs regarding move of Four UKNA cadres with automatic weapon in CCPur who were involved in various unlawful and anti national activities like extortion, drug business and smuggling and sale of weapons. The mobile numbers of these individuals were kept on surveillance for last two weeks. On 02 March 2025, location of one of the mobile was traced to Bethel, centre of town at 2145 hrs and it was further confirmed and corroborated by own sources.

3. A team of 36 Assam Rifles was immediately activated from HQ veng, CCPur led by a Nb Sub HL Hamal alongwith a Str of 30 individuals. The team laid a cordon to apprehen the suspected individual, who was being continuously tracked by sources. The team spotted a sentry posted outside the hideout, attempting to raise an alarm. Reacting instantly, the buddy pair leaped forward, nabbing the sentry in a swift takedown before he could alert the others.

4. When own team moved in to apprehend the persons on a pre- designated signal, the cadres tried to escape taking advantage of inclement weather and darkness in two directions taking their weapons in haste. Two cadres were caught at rear gate by alert team who overpowered them without firing a single round (keeping the safety of the local villagers and civilians who were in neighbouring houses in mind) and recovered one pistol from them. One cadre ran to his vehicle (Maruti Alto Car), started the car and tried to run the car over Assam Rifles soldiers in a bid to escape. Assessing the situation, column Cdr signalled to block the road with vehicles forcing him to stop. The suspect ran towards hill side following a stream. The team with utter disregard of personal safety chased the suspect in stream for approx 1 km and overpowered him after some struggle, forcing him to surrender at 0200 hrs on 03Mar 25 and one pistol was recovered from individuals possession. Thereafter the team of 36 Assam Rifles took the suspected person to Bn HQ Veng & questioned the suspected persons with respect to their identity, intent and activities. The suspected persons were kept in custody of 36 Assam Rifles at Quarter Guard during the questioning.

5. The suspected person was handed over to the police team on 03 Mar 25 at _____ hrs at CCPur PS with a No Claim , Medical & NOC certificate duly signed by suspects, police & 36 Assam Rifles. The suspects are to be produced before the Hon'ble Magistrate, Churachandpur (Manipur) for due legal action.

6. The investigation revealed the following :-

(a) The suspects claim to be member of Hmar National Army (HNA) and accepted that they joined HNA in Dec 24/ Jan 25. However, during sustained questioning it was learnt that they were members of the United Kuki National Army (UKNA) a non SoO group (all the individuals kept changing their statements). It is suspected that the individuals are active members of UKNA due to following reasons:-

(I) There were reports of FOUR armed cadres of UKNA in the said area carrying out extortion drug business ans smuggling & sale of weapons.

(II) That the said cadres are armed with pistols. They also confessed to being in possession of automatic rifles but the same could not be recovered.

(III) There were reports of training of new cadres by UKNA in Henglep area in Jan 25 and these four cadres have claimed to have joined the group in similar time.

(IV) The apprehended individuals are resident of / staying in Gamnom Kaprang and adjoining area which is dominated by UKNA. Moreover All the four cadres are Kuki and there is no reason for them to join a defunct SoO group like HNA. Hence, the conclusive evidence points that they are members of UKNA.

(V) There are no reports indicating recruitment by HNA, which is a SoO group, in CCPur. Futher, investigation is required to ascertain their identities and their involvement in other cases.

(b) On ivestigation about weapons, it is clear that the individuals have been smuggling & selling weapons in CCPur. A screenshot of conversation regarding sale & purchase is attached as Appendix A. The presence & dealing of the suspects in such weapons clearly indicates threat to national security & likely to cause unrest in the already fragile ethnic tensions in the state.

(c) On ivestigation about mobile phones carried by the suspects, it is revealed that he is part of an organized crime syndicate operational in several areas of churachandpur district (Manipur). Furthermore, such syndicate are felicitating move of drugs and weapons as well as troubling the general populace. Several contacts, photos, whatsapps chats, conversation messages were seen in the mobile phone of the suspect. Screenshots of some whatsapp group is attached as Appendix B.

(d) The suspects were in possession of illegal arms ans engaged in Anti National Activities.

(e) The suspects claim that they have been in CCPur for last 10 days and havent gone anywhere. However, Techint recd from Army sources contradicts their statements. The move pattern if individual in last 10 days, based on their mobile data activity, is attached as Appendix C and it clearly shows that the individuals have been frequenting areas where UKNA is active.

7. It is clear from the above investigation, that the suspect is heavily involved in several anti-national activities, thus challenging the writ of the state, rule of law & national security & Integrity & recommended to be caught under appropriate sections of IPC.

1. 36 Assam Rifles had been tracking the movement & activities of the apprehended individuals namely:-

- (a) Holkholal Khongsai @ Matthew S/O Gunkhomang Khongsai, r/o Gamngai, Chandel. Upon re-medical examination, indl complaint of dizziness and got admitted in District hospital Churachandpur. (OPD sheet att)
- (b) Ngamkhomang Haokip @ Jack S/O Jamkhong Haokip, r/o T. Munnumjang, Churachandpur
- (c) Ngamgoulen Haokip @ Hitler S/O Dongthang Haokip, r/o – Gamnom, Churachandpur
- (d) Janggoulun Haokip @ Marco S/O Khupngam Haokip, r/o – Pangmol, KPI

2. There were inputs regarding move of FOUR UKNA cadres with automatic weapon in CCpur who were involved in various **unlawful and anti national activities like extortion, drug business and smuggling and sale of weapons**. 5. The suspected person was handed over to the police team on 03 Mar 25 at _____ hrs at CCPur PS with a 'No Claim', Medical & NOC certificate duly signed by suspects, police & 36 Assam Rifles. The suspects are to be produced before the Hon'ble Magistrate, Churachandpur (Manipur) for due legal action.

6. The investigation revealed the following:-

(a) The suspects claim to be member of Hmar National Army (HNA) and accepted that they joined HNA in Dec 24/Jan 25. However, during sustained questioning it was learnt that they were members of the **United Kuki National Army (UKNA)**, a non SoO group (all the individuals kept changing their statements). It is suspected that the individuals are active members of UKNA due to following reasons:-

(i) There were reports of **FOUR** armed cadres of UKNA in the said area carrying out extortion, drug business and smuggling & sale of weapons.

(ii) That the said cadres are armed with pistols. They also confessed to being in possession of automatic rifles but the same could not be recovered.

(iii) There were reports of training of new cadres by UKNA in Henglep area in Jan 25 and these four cadres have claimed to have joined the group in similar time.

(iv) The apprehended individuals are resident of / staying in Gamnom, Kaprang and adjoining area which is dominated by UKNA. Moreover **ALL** the **FOUR** cadres are Kuki and there is no reason for them to join a defunct SoO group like HNA. Hence, the conclusive evidence points that they are members of UKNA.

(v) There are **NO** reports indicating recruitment by HNA, which is a SoO group, in CCpur. Further, investigation is required to ascertain their identities and their involvement in other cases.

(b) On investigation about weapons, it is clear that the individuals have been smuggling & selling weapons in CCpur. A screenshot of conversation regarding sale & purchase is attached as **Appendix A**. The presence & dealing of the suspects in such weapons clearly indicates threat to national security & likely to cause unrest in the already fragile ethnic tensions in the state.

(c) On investigation about mobile phones carried by the suspects, it is revealed that he is part of an organized crime syndicate operational in several areas of Churachandpur district (Manipur). Furthermore, such syndicates are facilitating move of drugs and weapons as well as are troubling the general populace. Several contacts, photos, WhatsApp chats, conversation messages were seen in the mobile phone of the suspect. Screenshots of some Whatsapp group is attached as **Appendix B**.

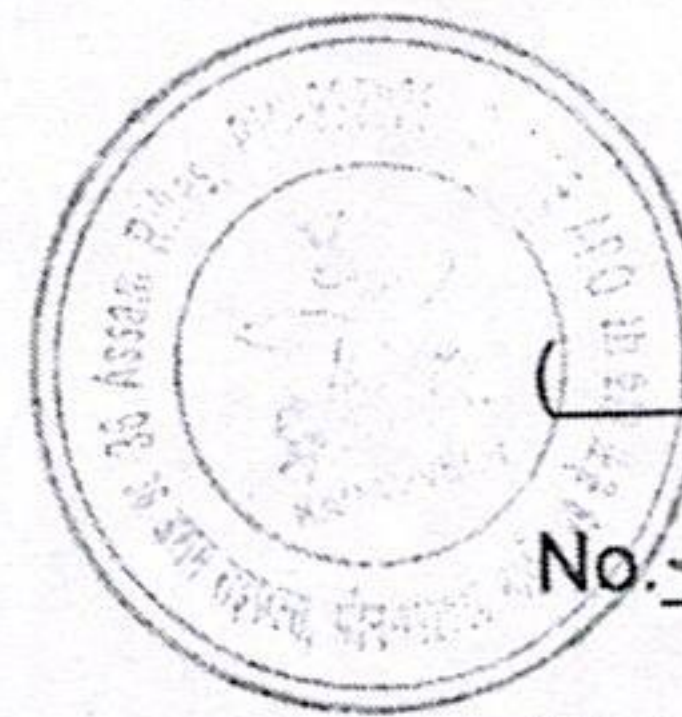
(d) The suspects were in possession of illegal arms and engaged in ANTI NATIONAL ACTIVITIES.

(e) The suspects claim that they have been in CCpur for last 10 days and haven't gone anywhere. However, Techint recd from Army sources contradicts their statement. The move pattern of individuals in last 10 days, based on their mobile data activity, is attached as **Appendix C** and it clearly shows that the individuals have been frequenting areas where UKNA is active.

7. It is clear from the above investigation, that the suspect is heavily involved in several anti-national activities, thus challenging the writ of the state, rule of law & national security & integrity & recommended to be charged under appropriate sections of IPC.
