**LODGING OF FIR AGAINST THANGSUANMUAN (AGE-44 YEARS) RESIDENT OF M TANGLIAN VILLAGE.**  
**CHURACHANDPUR-DISTRICT, MANIPUR**

1. There were some reports regarding drug transportation across Indo-Myanmar border during Jan-Feb 2025. Hence, 37 Assam Rifles activated its sources to dig out the input about drug cartel active in Churachandpur District. The sources identified a person who was actively involved in drug smuggling but he could not be apprehended red handed. Hence, one of the source was posed as drug buyer before the individual and the drug deal was finalised.
2. On 03 Mar 2025, information received from the source that the individual will come to deliver the drugs between 2000h-2200h on 03 Mar 2025. Hence, a column under Nb Sub Yogendra Baitha of 37 Assam Rifles was launched in general area Thingkangphai and hid at a location from where the target can easily be observed.
3. The individual came in a white Mahindra Bolero (Regd No MN 06 T 4192) and when the deal was taking place, the column of 37 Assam Rifles immediately ambushed them and apprehended Thangsuanmuan (age- 44 years), resident of M.Tanglian Village, Churachandpur -District, Manipur and recovered/seized following articles from him:-
  - (a) 132 x soap cases of No 4 Heroin (1.518 Kgs without soap cases) worth Rs. 15.4 crores.
  - (b) 01 x Vivo 1908 Mobile Phone.
  - (c) 01 x Mahindra bolero white Colour (Regd No MN 06 T 4192).
4. Considering security threats from the drug cartel, the individual was brought to Bn HQ, Khuga for further investigation and was kept in quarter guard of 37 Assam Rifles. The individual was handed over to Churachandpur Police Station at 1500 hours on 04 Mar 2025 and 'No claim certificate', No harassment certificate & medical certificate, seizure memo, handing/taking over were signed by the individual, police & 37 Assam rifles.



5. During the investigations, individual revealed following:-  
(a) The individual is involved in drug smuggling since last three years  
(b) He had procured the drugs from Ms Palnu (38 years), resident of Pangzawl, Churachandpur, Manipur and he supplies the drug to others on 5% commission basis from both parties i.e. he collects 10% commission on each deal.  
(c) Ms Palnu (38) yrs, resident of Pangzawl, Churachandpur, Manipur collects drug from a Myanmar national who transports drugs to Singhat, Churachandpur & other places in Manipur  
(d) It was also revealed that the indl is part of drug syndicate operating in Churachandpur and was involved in facilitating smuggling of their drugs to other dealers. Several contacts, photos, whatsapp chats, conversation messages were seen in the mobile phone of the individual.  
(e) Possibilities of links with insur gps instantly not established, however, cannot be ruled out.
6. It is clear from the above investigation that the Thangsuanmuan (age- 44 years), resident of M Tanglian Village, Churachandpur-District, Manipur is heavily involved in drug smuggling & a part of drug syndicate operating in Manipur & across Myanmar. The individual be charged under appropriate sections of IPC.

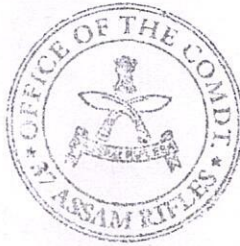
