I, Mr. L.Paukhanthang, a resident of Mualveng, Hiangtam Lamka, Churachandpur, Manipur would like to state that, I am a proprietor of M/s Zuanlian Langel Stone Crusher located at K.Gamnom Village, near Khuga Dam, Churachandpur, Manipur and has been running the said place for the past 5 years.

That, on 3rd May, 2023 an ethnic violence broke out which led to my business not running as it used to be and as such my business was closed down for many months and in 24th October, 2024 at around 10:30 AM when I went for an inspection at my stone crusher machine place, I came to realize that the parts of the machine were stolen by some unknown people and I took preventive measures. I started enquiring from people nearby, wherein they told me that things are being stolen again and again. I told the people staying nearby the stone quarry to be vigilant and in the later part of November, 2024, I was informed by the people staying near my stone quarry that the whole machine i.e. stone crusher and its parts has been stolen by some unknown miscreants. Due to enquiring to find out the unknown miscreants people it takes a delay report to the police.

These unknown miscreants looted the entire machine and the other equipment/accessories that comes along with and the total value of lost machine was worth around Rs.12,00,000/- (Rupees Twelve Lakhs).

I therefore, request you to kindly take actions against the perpetrators by registering an FIR under relevant sections of the statues of our country.


