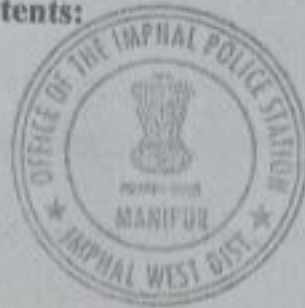

Sub: Forgery of documents/dates of birth and irregularities committed by the present Director, JN Manipur Dance Academy, D.M. College Campus, Shri P. Bilash Singh.

Sir,

I have the honour to state that Shri P. Bilash Singh, present Director, JNMDA produced many forgery documents to gain his personal benefit during the last more than thirty years since 1994. I have already kept informed in writing all the concerned authorities about his cancellation of his foreign trip as leader of a Cultural Troupe by the Indian Council of Cultural Relations (ICCR) because of his discrepancy of dates of birth in the month of August/September, 2022.

The irregularities committed by him through his forgery documents are as follows: He possesses three dates of birth -

(1) 1.8.1970 when he participated as a senior Badminton Player; he produced Imphal Municipal Corporation Date of Birth Certificate (Copy enclosed)

(2) 1.8.1975 when he applied for Indian Passport through which he travelled many countries. Surprisingly, recently he changed his date of birth as 1.3.1982 again in the Indian Passport;

(3) 1.3.1982 as per his service record. Surprisingly, he has possessed two Indian Passports. When he applied for Indian Passport in 2013, he deliberately did not use his correct date of birth - 1.3.1982 because of his personal gain. At that time, he passed his Matriculation Exam in 1999. (Copy enclosed).

Indian Council for Cultural Relations, Ministry of External Affairs, New Delhi cancelled his foreign trip in 2022 due to his date of birth discrepancy (Copy enclosed).

His RTI reply in which he himself admitted that he joined as a Dancer on contract basis in December, 2005 without appointment order (Copy enclosed). Series of complaints were lodged to the Controlling Authority, Sangeet Natak Akademi and Ministry of Culture, Government of India but no action has been taken up against him, though he has done all these blunders. All these irregularities were revealed in public domain both in Local Daily as well as the National Press (Copies enclosed).

In the circumstances stated above, I have no alternative but to take the legal help for the crimes he has committed and register an FIR against him for the forgeries he has made deliberately.
