I am a law-abiding citizen of India and I am the proprietor of Imphal Cab Service office located at Thangmeiband Yumnam Leikai, Imphal West.

That, on 2nd Oct, 2024, one customer namely Thounaojam Samananda Singh S/o Th. Romesh Singh of Lamdeng Mayai Leikai, P.O/P.S-Lamshang, Imphal West Manipur hired one Honda Amaze, white in colour, bearing Regn. No. MN01AS 8371 which is registered in the name of Toijam Meiraba Singh S/o T. 
