

Sir,

Today i.e. 15<sup>th</sup> Dec., 2024 at @ 05:50 PM, I have come across a viral post in social media "X" in which one Dr. Lamtinthang Haokip @ DrLamtinthang Hk posted from his account stating that "KUT, a post-harvest festival of the Chin-Kuki-Mizo tribal community, has been removed from the Gazette Holiday list for the 2025 calendar in Manipur by @BJP4India & its puppet administration" by using a manipulated scanned photo of Annexure –I of Government Order No.LIB-101/1/2022-GAD-GAD dated 9<sup>th</sup> December, 2024. The list of holidays for 2025 (SAKA) 1946 & 1947 for Government of Manipur.

The statement of Dr. Lamtinthang Haokip @ DrLamtinthang Hk directly incites the different communities living in the State specially Meiteis and Kuki Zo groups to escalate the conflict and create or promote feelings of enmity, hatred or ill will between Meitei/Meetei and Kuki community. He also advocates and incites to create more chaos, escalate violence, and make the situation unmanageable in order to meet their demands. His statement also incites section of public to agitate and revolt against the state which amounts to waging or attempting to wage war against the Govt. of India.

The actual number of general holidays for the year 2025 published by the Govt. of Manipur is 30 days in which in SI. No. 27 it clearly mentioned that "Kut Festival" is in the general holiday list. And Dr. Lamtinthang Haokip @ DrLamtinthang Hk intentionally manipulates the original one by deleting the list of some holidays including the "Kut Festival" making it only 23 days of general holidays instead of the actual 30 days using to be an original one and giving a false information to the general public.

It is therefore requested to kindly take up necessary legal action against the above mentioned person as per the law for the end of justice.
