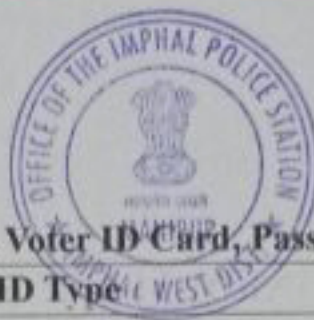

With due respect, I have the honour to submit the inquiry report for kind perusal and further necessary action with reference to the above mention G.D. Entry No.

The brief fact of the case is that one complainant namely Mutum Amarjit Singh, aged 42 yrs, S/o (L) M. Nimai Singh of Keishampat Mutum Leikai, Imphal West District, Manipur reported to the OC/Imphal Police Station on 1<sup>st</sup> October, 2024, stating that on the same day i.e. 1/10/2024, at around 7:00 pm, some unknown armed miscreants numbering about 6/7 persons who came on one SUV Bolero, White in colour having no Regd. No. forcefully entered his residence situated at Keishampat Mutum Leikai, Imphal. The unknown persons threatened him and his family members and snatched away his Fortuner Car, White in colour, Bearing Regn. No. MN02B-4739 which was parked at the courtyard of his house. The unknown persons threatened him and his family members with dire consequences if they inform to any security agency. Hence the case.

During the course of enquiry, the complainant was examined thoroughly in c/w the report and he fully corroborated with the report submitted by him. On further enquiry, efforts had been made to trace out the snatched Fortuner car and the unknown armed persons. Further, contacted source to have a look out and trace the snatched vehicle.

During the course of further enquiry, it was established that the said snatched vehicle was used by Asem Kanan Singh aged about 48 years S/o A. Ibochouba Singh of Uripok Sorbon Thingel, Imphal West District, Manipur and his associates.

It is therefore submitted this inquiry report to lodge a regular FIR case against the Asem Kanan Singh and his associates with relevant sections of law for further investigation of the case.




