With due respect, I have the honour to report that yesterday i.e. 13/02/2025 between 12.30 pm to 1.30 pm, my Honda Activa (Blue in colour) bearing regn. No. MN06SF-2053, Chassis No. ME4JF917MMW028767 & Engine No. JF91EW4028665, which was registered in the name of one Sapam Romen Singh S/o S. Ibocha Singh of Irengbam Mamang Leikai, Bishnupur was found stolen away by unknown person while parked at the entrance gate of my house located at Charangpat Maning Leikai, Thoubal under proper locked and was unable to locate after all the efforts put to trace out the same till date.
