That, I owned a Pucca building constructed under a Pucca Patta registered jointly in the name of one Mrs. Lheijaneng Touthang W/o Nandkishore Bhatt and one Ashvini Bhatt, of Phaipijang Joseph Colony, Meitei Langol, Imphal West District bearing Plot No. 2635/2673, Old Patta No. 268 and New Patta No. 3025/3471, located at Phaipijang Joseph Colony, opposite Langol Lainingthou, Meitei Langol, PS- Lamphel. Imphal West District, Manipur

However, due to the prevailing communal violence that broke out from 03-05-2023, we abandoned our house in the aftermath of the violence and fled for our safety as I am from Kuki community fearing that we might be killed. For a large period during violence, my house was safe and intact.

However, it came to our knowledge that my pucca building house was trespassed by unknown miscreants and all our belongings were stolen away and vandalized before the building structures were dismantled. We are unsure of when all our belongings were stolen away but it is learnt that the building structures were dismantled on 5th June, 2024.

Now, I am filing this report for favour of registration of Case FIR at your esteemed Police Station and to transfer the same to Lamphel Police Station for further necessary action.

So, in light of the above cited reasons, I request your good office to kindly accept my report and register an FIR Case under relevant section of Law.
