Sir,

Most respectfully, I would like to bring to your kind attention the unfortunate incident regarding the loss of my vehicle, a Maruti Car Expresso 2022 Model in Grey Colour, which was under the custody of Eastern Motors in Chingmeirong, Imphal, Manipur. I had initially deposited my vehicle with Eastern Motors on 19th April 2023 for repair due to some technical issues. However, due to the ongoing violence and conflict in Manipur, I was unable to visit Eastern Motors to follow up on the progress of the repairs. As I am from Churachanpur district, it was challenging for me to travel amidst the prevailing circumstances. I had complete confidence and trust in Eastern Motors to keep my vehicle safe and secure, considering their wellrecognized reputation in the state of Manipur. Unfortunately, the situation in the state continued to worsen, and the law and order were not properly maintained. Contacting Eastern Motors became increasingly difficult. On 3rd August 2023, the Works Manager (Service) of Eastern Motors informed me that there was a possible defect in the steering tie rod of certain vehicles manufactured between 5th July 2021 and 15th February 2023. This defect could potentially cause a breakage and affect the vehicle's steering and handling. As a precautionary measure, Maruti Suzuki India Limited (MSIL) decided to recall such vehicles. In June and July, I managed to contact Eastern Motors to inquire about the status of my vehicle's repair and they had assured me that they will update me. But on 19th June 2024, at around 9.15 A.M & 2.30 PM to my shock and surprise, they informed me that my vehicle had been forcefully taken by Arambai Tengol (AT) and has not been returned to Eastern Motors till today. Considering the situation in Manipur, I had no choice but to file this complaint petition, as my vehicle is property insured and I am required to submit the outcome of this complaint for insurance claim, if my vehicle could not be recovered from the lost

'In view of the facts and circumstances mentioned above, I respectfully request you to kindly register Zero FIR for the loss of my vehicle and forward the same to the concerned police station for doing the needful, in accordance with the law of the land.
