Sir,

I have the honour to state that today i.e. 17/12/2024 at about 02:30 pm, a reliable information was received from our own sources about the presence of some active cadres of KCP (PWG) organisation in and around Tangkhul Avenue area with a view to commit prejudicial activities like extortion of money from the general public, shops etc. Acting on the information, teams of CDO-IW led by Shri P. Achouba Meetei, MPS, OC-CDO-IW and myself under the command of Shri M. Amit Singh, Addl.SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW conducted cordon and search operation at Tangkhul Avenue. During that one person was seen standing near Shirui Lily Hotel, Tangkhul Avenue in a very suspicious manner. Due to his suspicious nature, he was detained at the spot for verification and checking. During spot verification, he identified himself as Chongtham Sachikanta Singh (22 yrs.) @ Kudukpa S/o. Ch. Ngoubpa Singh of Mayanglangjing Tamang, Imphal West District.

During preliminary verification, he disclosed that he is an active member of KCP(PWG) organisation and he is presently working under the command of one s/s Commander Laishram Rohit Singh @ Penaliz (aged about 24 yrs.) (Phone no. 8798803700) S/o. L. Bocha Singh from Mayanglangjing Tamang, Imphal West District of KCP(PWG) organisation. He further disclosed that today i.e. 17/12/2024, he along with his Commander namely Laishram Rohit Singh @ Penaliz had come together to serve monetary demands to various shops and beauty parlours/Spa located in and around Tangkhul Avenue area. He further revealed that his commander, Laishram Rohit Singh, also known as Penaliz, had entered the building of Hotel Shiroy Lily and that he was keeping watch. Immediately, I and two of my men went inside with Sachikanta to look for the commander but could not find him.

On spot body search, one Redmi Y2 mobile handset along with one Airtel SIM card bearing mobile number 9233125402 (as disclosed by him) was recovered from his possession.

Hence, he was arrested from the spot at 03:10 pm and the above recovered article was seized from the spot at 03:14 pm by observing formalities.

Hence, the arrested person along with the seized article is handed over to you for taking further necessary legal action against him.
