Sir,

I have the honour to report that on 31/12/2024 at about 5:30 AM, based on a specific input from own sources and corroborated by 5 Sikh Regiment about the movement of miscreants and caching of explosives, arms and ammunitions in the general area North of Thumkhonglok village near Khoijairok nalla under Loktak-PS, a combine team of Bishnupur District Police CDOs led by P. Sanjoy Singh, MPS, DSP(CDO-1)-BPR and Sub. Y. Shaktishen Singh, OC/CDO-BPR assisted by SI Ph. Birkumar Singh CDO-BPR, a team of Loktak-PS led by Inspt. Md. Abdul Gaffur Masood, OC/LTK-PS assisted by SI Rk. Ranjan Singh of LTK-PS under the command of Shri Amarjit Singh Lamabam, MPS, ASP (Ops-BPR), Two column of 5 Sikh Regiment led by Maj. Vikash and Capt. Paresh Mali and 1 section of B-38 SSB led by

AC Neeraj Bagdi under the overall supervision of Shri Rishabh Kumar Singh, IPS, SP-BPR conducted cordon and search operation in the said area. Some suspected area were cordoned from 0630 hrs and search started. In the operation the following arms and explosives items were recovered from the general area north of Thumkhonglok village near Khoijairok nalla at around 7:30 AM. Further the operation was closed at 8:00 AM.

**Particular of the seized items are:-**

- 12) Four nos. of 7.62 mm live rounds.
- 13) One no. of 9.2 mm (B47) live round.
- 14) One Mag. Pouch (Olive green).
- 15) One Mag. Pouch (Black in colour).
- 16) Two pairs of hunting boot/jungle.
- 17) One no. of belt(Black in colour)
- 18) Two nos. of Baofeng W.T.
- 19) Five nos. of 9.96 mm live rounds
- 20) Four nos. of 7.65 mm live rounds.
- 21) Twenty-Two nos. of 12 Bore live rounds along with one belt.
- 22) One Anti-Riot Gun(No marking)
- 23) One Single Barrel 12 Bore Gun( Mark as Suntokhoo Gun Works)
- 24) One no. of .303 rifle (Modified) without Mag.
