2. A special patrol was launched under command major Arshdeep Singh Gill with a Strength of 01 x JCO and 20 ORs along with AR Dog Rekha (ARL-558 ND) to general area BP-62 & Yangnomphai at around 2330 hour on 17 March. A detailed search was carried out in the area at around 0315 hour on 18 March 2025. While searching the area, the scout observed one package in the jungle and AR Dog Rekha further detected Suspected narcotic substances in the package. Upon checking the it found 4936 (24 blue plastic packets X 200, 1 blue plastic packet X 136) 16g WY tables were broke during transport and 10 x 12 bore single barrel rounds were found. Approx cost of the contraband items is Rs 14,80,800 Lakhs. Grade of the contraband item and ammunition are mentioned below.
