FIRST INFORMATION REPORT

Sir,

- 1. I have the honour to submit you the report that based on the input received from reliable sources at around 0830 hrs. on 07 March 2025, that presence of War Like Stores in general area SQ 6793, a party of strength 01-01-40 Ex COB Molcham under Major Madassar Hussain alongwith personnel of Molcham Police Station led ASI Maifalong Pashel were launched wef 070500 hours to search the area, post completion of extension period of deposition of illegal arms and ammunition by Governor of Manipur. The search party was divided into two groups to thoroughly search the vegetated area. At around 070830 hours one of the search party found a suspicious patch and on carrying out the detailed search of the patch, they found a hidden cache containing War Like Stores at GR 676936 and operations was culminated at 070900 hours.

 - a) 01 x 12 mm Single bore shot Sun.
 - b) 06 x Pompi
