Today i.e. 03/04/2025 at 6:00 AM, acting on intelligence about presence of bunkers and presence of huge arms cache in general area of Twichin and Salbol village under Yaingangpokpi police station.

A joint team of 4 MAHAR (BORDERS) under the command of Lt Col Vipin Dhillon and Yaingangpokpi police team led by Insp Yangmi Hashunao Shimray OC/YPI launched an intelligencebased search operation in the general area of Twichin and Saibol village along with one army ED dog and recovered huge cache of arms, ammunition, explosives, comn eqpt and war like stores hidden under the bunkers at general area Twichin and Saibol village. The security forces destroyed/ dismantled 13 tactically sited bunkers allegedly erected by Kuki armed group. The operation concluded at 1:00 PM on the same day. During the search operations at the said area the following arms, ammunitions, explosive etc. were recovered: -
