A combined security team led by Inspt Yangmi Hashunao Shimray, OC/YPI-PS along with Yaingangpokpi police team, one section of 4 MAHAR (BORDERS) under the command of Lt Col Vipin Dhillon, one section of A/189 Bn. CRPF, one section of B/69 Bn. BSF, one section of E/119 Bn. BSF, Spl. CDO and MR/IRB rushed to the spot and launched a massive operation at 4:30 AM and concluded at 08:30 AM on the same day. During the operations at the said area the following arms, ammunitions etc. were recovered: -
