I have the honour to report today i.e. the 21<sup>st</sup> March, 2025 at about 10:00 a.m. received a reliable information from our own intelligence about the presence of some extortionists belonging to the outfit RPF/PLA at Uchol area of Imphal East District. Based on the said information, a combined team of CDO/IE Unit and a column of 5/9 GR, under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)Imphal-East rushed to the said area and conducted a searched operation at Uchol Makha Leikai, Imphal East District about 10:40 a.m.

During that, one suspected person was detained for verification and checking. On verification, the detainee identified himself as one Laishram Romen Meitei (46 years) S/o (Late) L. Ibochouba Meitei of Uchol Makha Leikai, Andro PS, Imphal East District. On checking his body, one mobile phone and one wallet were found and recovered from his possession. On further verification, the detainee stated that he is an active member of the outfit RPF/PLA joined through one s/s – Finance Secy. Imphal East Mr. Melei of RPF/PLA in the month of January, 2024 and presently working under his command. On further verification, the detainee stated that on the advice of the said Mr. Melei of RPF/PLA he was involved in extortion of money from the general public for raising their party fund from the general area of Yairipok bazar.

In the light of the above facts and circumstances, the detainee was arrested from his residence i.e. Uchol Makha Leikai, Imphal East at 11:08 a.m. One mobile phone (Nokia TA-1553) bearing IMEI no. 359711911543527 & 359711911543535 along with one Airtel SIM Card bearing no. 8991000900021367076U and one wallet containing a sum of Rs. 100/- (one hundred rupees), one AADHAR card & one Voter Card were seized from his possession by observing due formalities from the spot i.e. Uchol Makha Leikai, Imphal East at 11:15 a.m.

Therefore, the arrested person along with the seized items is being handed over to you for taking up further necessary legal actions against him.




