I have the honour to report that today i.e. the 25th April, 2025 at about 2:00 a.m. received a reliable information from 4 AR corroborated with our own intelligence, about presence of one active member of the outlawed outfit PERPAK at Seijang Village, Imphal-East District. Based on the said information, a combined team of CDO/IE and a column of 4 Mahar Regiment under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri Y. Joyraj Singh, MPS Addl. SP(Ops)IE rushed to the said area and conducted a C.I. Ops. at 3:00 a.m.

In that, one suspicious unknown person was detained for spot verification and checking at Seijang Makha Leikai near Pukhri Achouba, Imphal East District. On checking his body, two nos. of mobile phones were found and recovered. On verification, the detainee identified himself as one Khongbantabam Samarjit Meitei @ Langamba (26 years) S/o – Kh. 


