I have the honour to report that today i.e. the 8th April, 2025 at about 12:00 noon received a reliable information from 4 AR corroborated with our own intelligence about the presence of some active members of the outlawed outfit PREPAK at Sagolmang, Imphal East District. Based on the said information, teams of CDO/IE Unit along with one team of Sagolmang PS led by Inspt. S. Basanta Singh OC-SGM/PS, under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops) Imphal-East rushed to the said area and conducted a C.I. Ops. at the said area at about 1:05 p.m.

As a part of the operation, random frisking and checking was conducted to the suspected passersby at Sagolmang Khewa, near CHC. In that one suspected person was detained for spot checking and verification. On checking his body, one mobile phone was found and recovered. On verification, the detainee identified himself as one Sapam Sagar Singh @

Satongba (30 years) S/o S. Romajit Singh of Leimakhong Mapal, Lamlai, Imphal-East District. On further verification, the detainee stated that he is an active member of the outfit PREPAK (Pro) joined through one Mr. Manglem of PREPAK (Pro) in the month of January, 2024 and presently working under the command of the said Mr. Manglem.
