I have the honour to report that today i.e. the 10<sup>th</sup> April, 2025 at about 7:30 a.m. received an information from 4 AR corroborated with our own intelligence about the concealment of a nos. of arms, ammunitions and explosives by unknown arms miscreants in general area of Pukhao Ahallup and its adjoining areas of Imphal East District. Based on the said information, a combined team of CDO/IE Unit assisted by SI. W. Ronny Singh of CDO/IE and G169 CRPF along with teams of RI, Imphal East and SMG/PS led by Inspt. S. Basanta Singh OC-SMG/PS under the overall command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops) Imphal East District conducted a searched operation in the general area Pukhao Ahallup and its adjoining areas of Imphal East District at about 8:20 a.m.

During the search operation, found one sack bag hidden in a bush at the western side river bank of Pukhao Ahallup, Imphal East, which is about 1.5 Km to the northern side of Community Hall of Phukao Phurju village at 9:06 a.m.
