They also asked for a ransom of Rs. 10,00,000/- (Rupees Ten Lakhs) out of which Rs 1,00,000 (Rupees One Lakh) has been paid by the Thayong Village Authority. But still the two kidnap persons are yet to release.

Therefore, I regret to your kind interference in bringing back the two(2) kidnapped person safely.
