I have the honour to report today i.e. the 23rd February, 2025 at about 5:00 p.m. received a reliable information about the presence of some extortionists at Chingarel Tejpur Sawombung, Imphal-East. Based on the said information, a combined team of CDO/IE and 33 AR under the supervision of Shri. Kh. Herojit Singh, MPS Addl. SP(Ops)Imphal-East rushed to the said area and conducted random frisking and checking to the suspected passersby at 5:30 p.m.

In that, one suspected person was detained for verification and checking at Chingarel Tejpur near On verification, the detainee identified himself as one **Damu Kangjam @ Ningjaba, aged about 47 years, S/o - K. Modhumangol Singh of Uripok Huidrom Leikai, Imphal PS, Imphal West**. On further verification, the detainee stated that he is an active member of the outfit KCP (Noyon) joined through one Mrs. Binakumari and got his basic military training in the same year for three months at Taka, Myanmar (Eastern Nagaland) under the command of one s/s - Corporal Mr. Bablu of KCP (Noyon) with allotted army no. 475 of 31 bath. The detainee further stated that he is involved in extortion of money from the general public, private firms, govt. Officials etc for raising their party fund.

So, the detainee was arrested from the spot i.e. Chingarel Tejpur, Imphal East District, at 6:28 p.m. by observing due formalities.

Therefore, the arrested person is being handed over to you for taking up further necessary legal actions against him.
