I have the honour to report that I was married to my 2nd husband namely Khongbantabam Kinan (49) S/o Kh. Krishnamohon of Nongada Makha Leikai in 2017. After our marriage, I moved in with my son and daughter from my previous marriage to his residence and stayed together. Unfortunately, I was deeply concerned that my husband's behaviour was causing distress and he was harassing my children on many occasions. On 19/2/2025 at

about 10:00 pm, my son namely Belay Dutt (17) yrs was beaten up badly by my husband (Kiran) as a result of which he had bleeding from the ear and had passed out for some minutes due to the impact of the physical assault. After some minutes he regained his consciousness. On the next day i.e. 20/2/2025 my son was admitted to Sawombung PHC for medical treatment. After receiving medical treatment in the evening on the same day i.e. 20/2/2025, the concerned doctor referred his treatment to JNIMS/RIMS Hospital for further medical treatment. As I could not afford his further medical treatment, I along with my son (injured) came back to one of my neighbour sister's house namely Kamala located at Kameng Khunjao and spent the night there with my son. On the next day i.e. 21/2/2025 at about 7:30 am, my son complained that he was having a serious breathing problems and immediately evacuated to JNIMS Hospital for medical treatment. However, my son succumbed to his injury at JNIMS Hospital. Above all the certificate for medical treatment of my son has been concealed.

It is therefore requested to kindly take up necessary legal action. Above
