13. First Information contents:

Today i.e. 01/03/2025 at 10:20 received an information that on the same day i.e. 01/03/2025 at around 9:45 am, a clash broke out between some 500 villagers of Nongada village and Kameng village at their disputed Play Ground located near BIKOM High School during a religious procession (Saroi Khangba) over a land dispute between the two villages. A police team of Lamlai PS including women police personnel which was already at the spot for precautionary measures in c/w the procession (Saroi Khangba) could not prevent the clash as the mob outnumbered the police personnel deployed there. As the clash escalated police team resorted to firing tear gas shells, Smoke bombs to disperse the unruly mob on seeking permission from Executive Magistrate. However, the clash still continued. At around 10:10 am Addl. SP(Traffic) and his team, DSP(Ops), SDPO-in-Charge and his team, RI-Imphal East, 1 team of CDO-IE arrived at the spot as reinforcements and we were finally able to disperse the mob completely. During the clash which included pelting of stones and scuffles amongst the mob, some villagers sustained injuries.

Hence, a Suo-Mottu case under FIR No. 15(3)2025, LLI-PS U/S 189(4)/191(2)/3(5) BNS has been registered for investigation.
