I, the undersigned, on behalf of Nongada Village Development Committee Nongada, The ELC, Nongada and Nongada Meira Paibi Apunba Lup hereby report that, today, on 1st March 2025 at about 10:00 am, the 1st Saturday of Lamda while the Meira Imas are trying to Saroi Khangba for our village, Nongada, some 150 (one hundred fifty) women along with some boys try to cross the border line between the Kameng village and my Nongada village carrying the things (Singju and others) to be tributed to the Lamlai (Satan), our Meira Imas asked them not to do. But they forcibly cross by beating, pulling hair, biting scratching, pelting stone as in a planned manner. It injured about 20 women of our village. That I hereby enclosed the MLC reports of six injured for your kind knowledge. That, the women were led by the followings
