Sir.

I have the honour to report that today i.e. the 6th March, 2025 at about 4:00 p.m. received an information from a reliable source about the concealment of a nos. of arms, ammunitions and explosives by unknown arms miscreants in and around Sawombung and Pourabi villages of Imphal East District. Based on the said information, a combined team of CDO, Imphal East Unit, District Police Imphal East, 8 Bihar Regiment, 29 BSF and 33 BSF conducted a searched operation in the general area of Sowumbung – Paorabi villages of Imphal East District at about 4:30 p.m.

During the search operation an abandoned located at the paddy filed which is about 300 meters away to the northern side of FCI godown, there found one 303 rifle bayonet. On further searching around the said area, there found one white sack bag, suspected to be containing a nos. of arms, ammunitions and explosives, at the paddy field which is about 500 meters away to the northern side of FCI Godwon, Sawombung, Imphal East District. While our combined team tried to open and checked the said sack bag, a large nos. of crowd approached towards at the spot and enquired us, why the searched operation was being conducted at the area. Our combined team tried to convince the crowd, but the crowd become unruly and started shouting and interfering our further procedures. They mob even tried to snatch the recovered sack bag, which suspiciously contained arms ammunitions and explosives. Considering the situation, our combined team hurriedly and by using minimal force bring out the recovered sack bag, however the further formal procedures and mandatory provision of photography and videography could not be done due to the said situation.

On reaching the office of CDO/IE Unit, our Combined team open the above recovered sack bag and there found the undernoted arms, ammunitions and explosives;

- 1. I(one) no. of 7.62 mm SLR rifle marked as "AA 0565" with magazine,
- 2. 1(one) no. of Amogh Carbine marked as "AA1192" with 2(two) magazine,
- 3. 2(nos. of 36 Hand grenade,
- 4. I(one) no. of 9 mm pistol,
- 5. 1(one) no. of 9 mm pistol,
- 6. I(one) no. of 9 mm Pistol marked as " Auto Pistol 255/13ALKM" with magazine,
- 7. 19(nineteen) nos. of 5.56 X30 mm Amogh carbine Ammunitions and
- 8. 5(five) nos. of 7.62 mm SLR rifle ammunitions,

Accordingly, the above recovered arms, ammunitions and explosives were seized at the office of CDO/IE Unit, Porompat Imphal East District, Manipur by observing due formalities at 5:49 p.m.
