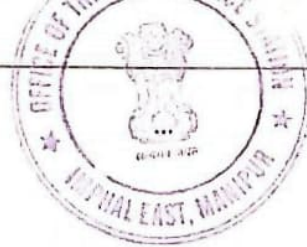

Sub:- Report.

Sir,

I have the honour to report that today i.e. 11th March, 2025, at about 6:00 a.m. a reliable input was received about the presence of some armed active member of the outlaw outfit KYKL in and around Nongpok Sanjenbam, Imphal-East District. Based on the said information, at about 6:40 a.m. a combined team of CDO Imphal East Unit and a column of 5/9 GR under the command of Inspt. Kh. Henery Singh, Officer-in-Charge Commando Imphal-East Unit and under the supervision of Shri. Y. Joyraj Singh, MPS, Addl. SP(Ops) Imphal East District rushed to the said area and conducted a Counter Insurgency Operation. In that, one suspected person was detained for spot verification and checking. On checking, 45 (forty-five) nos. of 7.62 mm AK rifle ammunitions were found and recovered from his possession.

On verification, the first detainee identified himself as one **Konjengbam Ibomcha Meitei (54 years) S/o (Late) K. Nawang Meitei of Soibam Leikai Ahongei Leirak, Porompat PS, Imphal East District, Manipur** an active member of the outlaw outfit KYKL. On further verification, the detainee stated that, he joined the outfit in the month of May, 2023 through one Mr. Naoba of KYKL and presently working under the command of the said Mr. Naoba. The detainee is also indulged transportation of arms and ammunitions on the advice of the said Mr. Naoba of KYKL.

So, the detainee was arrested from the spot i.e. Sanjembam Khullen Village, near Waiting Shed Imphal East District at 7:38 a.m. by observing necessary formalities and seized; (i) 45 (forty five) nos. of 7.62 mm AK rifle ammunitions, (ii) one mobile phone (Redmi 9A) bearing IMEI No.86357050570784 & 86357050570792 along with one Airtel SIM card bearing no. 8991160990002033611U and (iii) One wallet containing one AADHAR card from his possession at the spot i.e. Sanjembam Khullen Village, near Waiting Shed Imphal East District at 7:45 a.m. by observing due formalities.

Thereafter, the arrested person along with the seized ammunitions is being handed over to you for taking up further necessary legal procedures against him.
