Sir,



I have the honour to state that today i.e. 26/03/2025 at about 03:36 pm, a reliable information was received regarding the presence of some active cadres of KYKL organisation in and around Takhel area of Imphal East District with a view to commit prejudicial activities like extortion of money from the general public and shops etc. Acting on the information, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri P. Achouba Meetei, MPS, DSP(CDO)/IW and under the supervision of Shri M. Amit Singh, Addl. SP(Ops.)/IW and under the overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room (OSCAR 1) at around 03:42 pm and conducted search operation at Takhel Mamang Leikai area of Imphal East District. During that one unknown person was seen sitting near a Himalayan Royal Enfield motorcycle white in colour near the foothill of Takhel Mamang Leikai in a very suspicious manner. Due to his suspicious manner, he was detained at the spot for verification and checking.

During spot verification, he identified himself as Naorem Naren Meitei (25 yrs.) @ Leishemba @ Irabot S/o. N. Shyam Meetei of Takhel Mamang Leikai, Imphal East District.

On spot checking, the following articles were recovered from his possession:

- (1) One Redmi Note 8 mobile handset along with one Airtel SIM card bearing mobile no. 6909973963 (as disclosed by him),
- (2) One black wallet containing a sum of Rs. 500/- (rupees five hundred only), one Aadhaar card bearing no. 4332 1464 4225 and one vehicle registration card bearing registration number TR01AB5494.

During preliminary verification, he disclosed that he is an active member of KYKL organisation and joined the said organisation in May, 2023 through one Pakpa from Takhel Mayai Leikai who is also an active member of KYKL organisation and he is presently working under the command of one s/s Commander Santosh (Ph. No. 8414814189) from Sugnu who is presently staying at Heirok. On further verification, he disclosed that he received the above mentioned Himalayan Royal Enfield motorcycle white in colour from his commander Santosh at Kairembikhok on 20/03/2025 to be used in their party activities. As pointed out by him, the said Himalayan Royal Enfield motorcycle white in colour bearing registration number TR01AB5494 along with its key was recovered from the spot at his instance.

Hence, he was arrested from the spot at 04:37 pm and the above recovered articles were seized at 04:45 pm respectively by observing formalities.

Hence, the arrested person and the seized articles are handed over to you for taking further necessary legal action against him.
