Subject : Report

Sir,

I have the honour to report that today i.e. the 27th March, 2025 at about 4:30 p.m. received a reliable information about the presence of some active members of the outlaw outfit KCP at Sawombung Imphal East District. Based on the said information, teams of CDO/IE Unit under the command of Inspt. Kh. Hcnery Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops) Imphal-East rushed to the said area and conducted a searched operation at the said area at about 5:00 p.m.

As part of the searched operation random frisking and checking was conducted to suspected passersby. In that, one suspected person was detained for verification at Sawombung Pourabi Road, near FCI Godown. On verification, the detainee identified himself as one **Likmabam Amujao Meitei @ Lakpa**, aged about 27 years, S/o L. Noyon Meitei of Keibi Awang Leikai, Imphal East District an active member of the outlaw outfit KCP – PSC (Politburo Standing Committee) group.

On further verification, the detainee stated that he joined the said outlaw outfit through one Mr. Thouba of KCP (PSC) group and got his basic military training in month October, 2024 and allotted army no. 214A under the command of one Mr. Pari. He further stated that he is presently holding the rank of s/s – Private of their outfit and working under the command of the said Mr. Pari of KCP (PSC) group.

So, the detainee was arrested from the spot i.e. Sawombung Pourabi Road near FCI Godown, Imphal East District at 5:20 p.m. by observing due formalities.

Therefore, the arrested person is being handed over to you for taking up further necessary legal actions against him.
