Sir,

I have the honour to report that today i.e. the 29th March, 2025 at about 2:00 p.m. received a reliable information from 33 AR corroborated with our intelligence about the presence of some active members of the outlawed outfit KCP at Sawombung Imphal East District. Based on the said information, teams of CDO/IE Unit under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)Imphal-East rushed to the said area and conducted a searched operation at the said area at about 3:00 p.m.

As part of the searched operation, one suspected house was cordoned and detained one suspected person. On verification, the suspected person identified himself as one **Sanasam Sonamit Singh @ Chekla @ Sonamani @ Naoba (27 years) S/o S. Ranjan Singh of Sawombung Maning Leikai, Lamlai PS, Imphal East District**. On checking his body one mobile phone was found and recovered from his possession. On further verification, the detainee stated that he is an active member of the outlawed outfit KCP – PWG group.

On further verification, the detainee stated that he joined the said outlawed outfit through one Mr. Khaba of KCP (PWG) group in the month of November, 2024 and got his basic military training in the same year 2024 under the command of one Mr. Shakhen. The arrestee is presently working under the command of the said Mr. Khaba of KCP (PWG) group.

So, the detainee was arrested from his residence i.e. Sawombung Maning Leikai, Lamlai PS, Imphal East District at 3:32 p.m. by observing due formalities. One mobile phone (Redmi C20) bearing IMEI no. 861759055420557/68 & 861759055420540/68 along with one Airtel SIM card bearing no. 8991160990026804754U was seized from the possession of the arrestee at 3:40 p.m. by observing due formalities.

Therefore, the arrested person along with the seized mobile phone is being handed over to you for taking up further necessary legal actions against him.
